Ordinance No. 93-003

AN ORDINANCE ANNEXING INTO THE CORPORATE BOUNDARIES
OF THE CITY OF CAMPBELLSVILLE, KENTUCKY,
CERTAIN TRACTS OR PARCELS OF LAND LYING IN TAYLOR COUNTY
AND BELONGING TO DAYTON THOMAS MILBY.

WHEREAS, the City of Campbellsville has heretofore proposed an Ordinance to annex the within described area, said Ordinance being read on the 1st day of February, 1993, and the 1st day of March, 1993.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMPBELLSVILLE, KENTUCKY AS FOLLOWS:

Pursuant to the provisions of KRS Chapter 81A, the City Council of the City of Campbellsville, Kentucky, does hereby annex into the corporate boundaries of the City of Campbellsville, Kentucky, the hereinafter described property; and further, the City Council does hereby declare that the annexation is desirable to the needs of the City of Campbellsville, Kentucky; and, further, the City Council does hereby state that the area to be annexed is urban in character and that to the annexation it was an unincorporated territory.

The land hereby annexed is described as follows:

Beginning at a post (which post bears North 53 degrees 03 minutes East 183.0 feet from a post on the northwest side of Old Greensburg Road, corner of the Harlon Barnett property) on the north side of Old Greensburg Road, said post being a new division corner in the Dayton Thomas Milby property (Deed Book 174, Page 249); thence with new division lines in said Milby property as follows: North 11 degrees 05 minutes West 178.1 feet to an iron pin, set this survey; North 80 degrees 53 minutes East 70.0 feet to an iron pin, set this survey; South 11 degrees 05 minutes East 177.6 feet to an iron pin, set this survey, on the north side of said Old Greensburg Road, said iron pin being a new division corner in said Milby property; thence with the north side of said Old Greensburg Road as follows: South 83 degrees 52 minutes West 37.3 feet; South 76 degrees 35 minutes West 32.8 feet to the beginning containing 0.28 acre.

This property is hereby zoned I-2.




ANNEXATION MAP (NOT FOR LAND TRANSFER)
