

AN ORDINANCE ANNEXING INTO THE CORPORATE BOUNDARIES OF THE CITY OF CAMPBELLSVILLE, KENTUCKY, CERTAIN TRACTS OR PARCELS OF LAND LYING ON THE HEARON ROAD BELONGING TO CHARLES LYNDON CHAMBERS.

WHEREAS, the City of Campbellsville has heretofore proposed an Ordinance to annex the within described area, said Ordinance being read on the 2nd day of May, 1988; and the 16th day of May, 1988; and thereafter said proposed Ordinance annexing the within described property having been advertised in toto in the Central Kentucky News Journal on the 19th day of May, 1988.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMPBELLSVILLE, KENTUCKY AS FOLLOWS:

Pursuant to the provisions of KRS Chapter 81A, the City Council of the City of Campbellsville, Kentucky, does hereby annex into the corporate boundaries of the City of Campbellsville, Kentucky, the hereinafter described properties, and further the City Council does hereby declare that the annexation is desirable to the needs of the City of Campbellsville, Kentucky; does further state that the area to be annexed is urban in character and that prior to the annexation it was an unincorporated territory.

The land hereby annexed is described as follows:

TRACT 1:

Beginning at an iron pin on the north side of the right of way between Mrs. Dollie Roots and Lawrence E. Roots, corner of Bobby Callison and Lawrence Roots; thence with the line of said Bobby Callison and then William O'Banion N 2-1/4 W 269 feet to a stake, a division corner in the land of Lawrence E. Roots in the line of William O'Banion; thence with a division line in the land of said Lawrence E. roots N 49-1/2 E 210 feet to a stake, another division corner in the land of said Lawrence E. Roots; thence with another division line in the land of said Lawrence E. Roots S 37-3/4 E 210 feet to a stake on the North side of the aforementioned right of way, corner of Lawrence E. Roots and Mrs. Dollie Roots; thence with said right of way S 49-1/2 W 364 feet to the beginning, containing 1.4 acre more or less.

TRACT 2:

Beginning at an iron stake on the north side of the right of way between the land of Mrs. Dollie Roots and Lawrence E. Roots, corner of said Dollie Roots and Lawrence Roots; thence with the line of said Dollie Roots and Lawrence E. Roots N 6-3/4 W 143 feet to a stake, a division corner in the land of Mrs. Dollie Roots in the line of said Lawrence E. Roots; thence with a division line in the land of said Mrs. Dollie Roots S 37-3.4 E 121 feet to a stake, another division line in the land of said Mrs. Dollie Roots S 49-1/2 W 74 feet to the beginning, containing 6,147 sq. feet.

TRACT 3:

Beginning at an iron post on the west side of Tharp Drive, corner of the Charles Lyndon Chambers property (Deed book 163, page 471) and the Lawrence E. Roots property (Deed book 94, page 297); thence with the east line of said Chambers property N 40-33 W 58.45 feet to a point in the east line of said Chambers property, said point also being a new divi-


sion corner in said Lawrence E. Roots property; thence with a new division line in said Roots property N 71-54 E 29.63 feet to an iron post (a new corner) on the west side of said Tharp Drive; thence with the west side of said Tharp Drive S 10-23 E 54.5 feet to the beginning containing 800 square feet.

This property is hereby zoned R-3.

This Ordinance was introduced and given a first reading and passage at a regular meeting of the City Council held on the 1st day of August, 1988; it received its second reading, passage and became effective at a regular meeting of the City Council held on the 15th day of August, 1988.


