

**RESOLUTION 10-66**

**A RESOLUTION ADOPTING A MODERN AND ACCURATE LEGAL  
DESCRIPTION OF TERRITORY PREVIOUSLY ANNEXED BY  
ORDINANCE**

WHEREAS, the City of Campbellsville has enacted numerous ordinances annexing property into the corporate limits of the City of Campbellsville; and

WHEREAS, each individual annexation contains a prior survey oft prepared by now unknown individual, and further references documentation that is no longer in existence; and

WHEREAS, the City wishes to provide a modern, accurate, easily identifiable legal description reflecting bearings and coordinates based upon the state plane coordinate system, including relevant GPS and GIS data, same having been certified by a professional land surveyor for each prior annexation; and

WHEREAS, the City wishes to comply with the requirements of Amended KRS 81A.40 effective July 13, 2004, and

WHEREAS, the City does not intend to amend or replace its prior ordinance annexing, but rather to interpret the defined boundaries of the territory previously annexed and adopt a modern and accurate legal description of territory previously annexed.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CAMPBELLSVILLE, KENTUCKY:

SECTION 1. That the City Council of the City of Campbellsville hereby adopts the following legal description, and a plat attached hereto as prepared by Robert L. Miller Jr, Licensed Professional Land Surveyor No. 2282 by new survey as an accurate depiction of the property previously annexed into the corporate city limits of the City of Campbellsville by Ordinance dated September 17<sup>th</sup>, 1979, a copy of which is attached hereto as Exhibit "2", and hereby adopts said new legal description and plat as the official legal description and plat to be adopted by the City for all purposes when referencing this prior annexation.


SECTION 2. This new legal description as prepared by Robert L. Miller Jr., a Licensed Professional Land Surveyor No. 2282 is as follows:

ORDINANCE DATED SEPTEMBER 17, 1979**

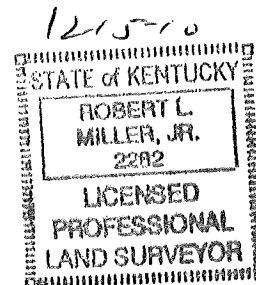
A certain tract of land located at the north end of North Columbia Avenue in Campbellsville in Taylor County, Kentucky, and being more particularly described as follows:

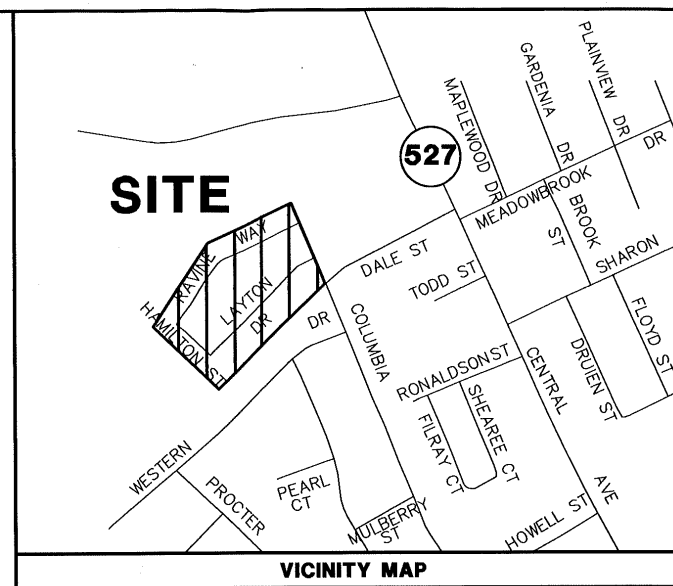
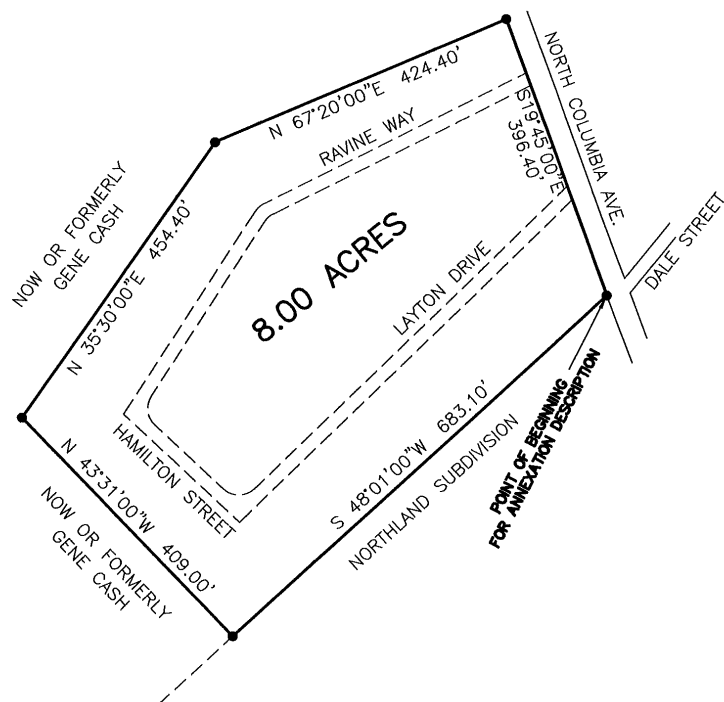
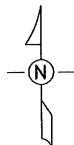
Beginning at a point on the west side of North Columbia Avenue at its intersection with Dale Street, corner of the Northland Subdivision; thence with the line of said Northland Subdivision South 48 degrees 01 minutes 00 seconds West 683.10 feet to a point in the line of said subdivision, corner of property now or formerly owned by Gene Cash; thence with the lines of said Cash property as follows: North 43 degrees 31 minutes 00 seconds West 409.00 feet; North 35 degrees 30 minutes 00 seconds East 454.40 feet; North 67 degrees 20 minutes 00 seconds East 424.40 feet; thence with the west side of said North Columbia Avenue South 19 degrees 45 minutes 00 seconds East 396.40 feet to the beginning containing 8.00 acres.

The above description is based on a survey by Robert L. Miller, Jr. in 1979 and also a deed as recorded in Deed Book 142, Page 196 in the Taylor County Clerk's office.

The above description is for annexation purposes only and is not to be used for land transfer.

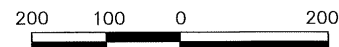
