AN ORDINANCE ANNEXING INTO  
THE CORPORATE BOUNDARIES  
OF THE CITY OF  
CAMBELLSVILLE, KENTUCKY  
CERTAIN PROPERTIES LYING  
ON SMITH RIDGE ROAD.

WHEREAS, the City of Campbellsville has heretofore proposed an Ordinance to annex the within described area, said Ordinance being read on the 17th day of August, 1987; and the 8th day of September, 1987, and thereafter said proposed Ordinance annexing the within described property having been advertised in toto in the Central Kentucky News Journal on the 17th day of September, 1987.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMBELLSVILLE, KENTUCKY AS FOLLOWS:

Pursuant to the provisions of KRS Chapter 81A, the City Council of the City of Campbellsville, Kentucky, does hereby annex into the corporate boundaries of the City of Campbellsville, Kentucky, the hereinafter described properties, and further the City Council does hereby declare that the annexation is desirable to the needs of the City of Campbellsville, Kentucky; does further state that the area to be annexed is urban in character and that prior to the annexation it was an unincorporated territory.


The land hereby annexed is described as follows:


A certain tract or parcel of land lying and being in Campbellsville, Taylor County, Kentucky, and being described as follows; Beginning at an iron pin on the west side of Kentucky Highway #372-Smith Ridge Road, corner of the Jesse Parker property; thence with the line of said Parker property N 77-45 W 125 ft. to a fence post in the line of the Thurman Watson property, corner of said Parker property; thence with the line of said Watson property N 00-09 E 48 ft. to an iron pin in the line of said Watson property, said iron pin being a new division corner in the Merle Wise property; thence with a new division line in said Wise property S 83-15 E 131.7 ft. to an iron pin on the west side of said Kentucky Highway #372, said iron pin being a new division corner in said Wise property; thence with the west side of said Kentucky Highway #372 S 08-32 W 59.7 ft. to the beginning containing 0.16 acre more or less.

This property is hereby zoned R-3.

This Ordinance was introduced and given a first reading and passage at a regular meeting of the City Council held on the 21st day of December, 1987; it received its second reading, passage and became effective at a regular meeting of the City Council held on the 4th day of January, 1988.

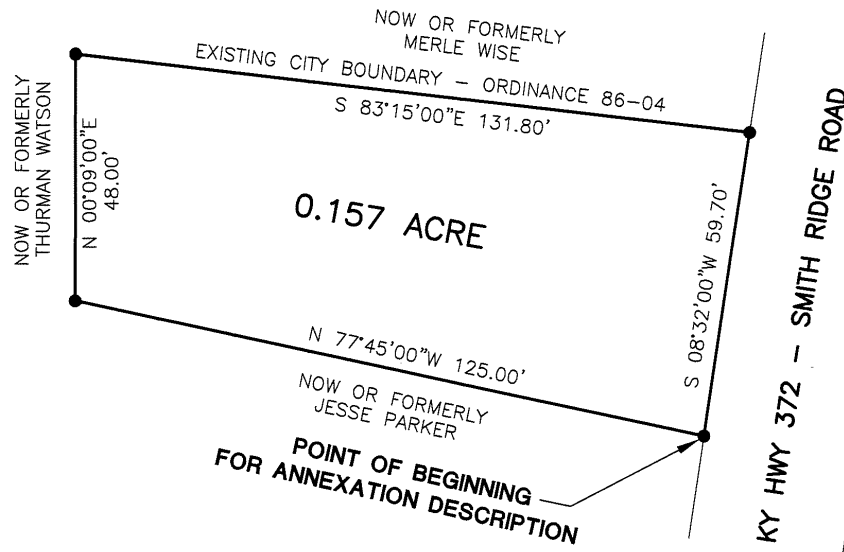

**VICINITY MAP**



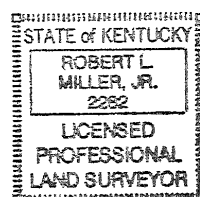

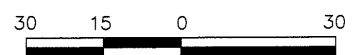
