

ORDINANCE NO. 10 - 11

**AN ORDINANCE ANNEXING INTO THE BOUNDARIES
OF THE CITY OF CAMPBELLVILLE, KENTUCKY,
A CERTAIN TRACT OR PARCEL OF LAND LYING IN TAYLOR
COUNTY AND BELONGING TO NEAL BURRESS, et ux**

The City of Campbellsville has received a written request (consent) for annexation of the property described below, thereby eliminating the requirement of a proposed Ordinance for annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMPBELLVILLE, KENTUCKY AS FOLLOWS:

Pursuant to the provisions of KRS Chapter 81A, the City Council of the City of Campbellsville, Kentucky, does hereby annex into the boundaries of the City of Campbellsville, Kentucky, the below-described property; and further, the City Council does hereby declare that the annexation is desirable to the needs of the City of Campbellsville, Kentucky; and, further, the City Council does hereby state that the area annexed is urban in character and that prior to the annexation it was an unincorporated territory.

A certain tract of land located at the east limits of Campbellsville and being part of Meadowview Drive and all of Lot #14 of Meadowview Subdivision and being described as follows:

Beginning at a point at the southwest corner of the intersection of Kentucky Highway 70 and Meadowview Drive, said point being a corner of the existing City of Campbellsville boundary; thence with the south side of said Kentucky Highway 70 South 64 degrees 17 minutes 07 seconds East 53.04 feet to a point on the southwest side of said Meadowview Drive; thence with the southwest side of said Meadowview Drive South 45 degrees 12 minutes 13 seconds West 215.17 feet to a point on the southwest side of said Meadowview Drive; thence with the common line of Lot 13 and 14 of Meadowview Subdivision South 46 degrees 30 minutes 51 seconds East 143.84 feet to a point; thence South 44 degrees 40 minutes 27 seconds West 100.00 feet to a point; thence with the common line between Lot 14 and Lot 15 of said Subdivision North 46 degrees 30 minutes 18 seconds West 144.77 feet to a point on the southwest side of said Meadowview Drive; thence crossing said Meadowview Drive North 44 degrees 47 minutes 47 seconds West 50.00 feet to a point on the northwest side of said Meadowview Drive; thence with the northwest side of said Meadowview Drive North 45 degrees 12 minutes 13 seconds East 297.48 feet to the beginning containing 0.68 acre.

The above description is based on information taken from a plat of Meadowview Subdivision in Plat Cabinet A, Slide 21 in the Taylor County Clerk's office.


**ANNEXATION DESCRIPTION FOR CITY OF CAMPBELLSVILLE

Beginning at a point at the southwest corner of the intersection of Kentucky Highway 70 and Meadowview Drive, said point being a corner of the existing City of Campbellsville boundary; thence with the south side of said Kentucky Highway 70 South 64 degrees 17 minutes 07 seconds East 53.04 feet to a point on the southwest side of said Meadowview Drive; thence with the southwest side of said Meadowview Drive South 45 degrees 12 minutes 13 seconds West 215.17 feet to a point on the southwest side of said Meadowview Drive; thence with the common line of Lot 13 and 14 of Meadowview Subdivision South 46 degrees 30 minutes 51 seconds East 143.84 feet to a point; thence South 44 degrees 40 minutes 27 seconds West 100.00 feet to a point; thence with the common line between Lot 14 and Lot 15 of said Subdivision North 46 degrees 30 minutes 18 seconds West 144.77 feet to a point on the southwest side of said Meadowview Drive; thence crossing said Meadowview Drive North 44 degrees 47 minutes 47 seconds West 50.00 feet to a point on the northwest side of said Meadowview Drive; thence with the northwest side of said Meadowview Drive North 45 degrees 12 minutes 13 seconds East 297.48 feet to the beginning containing 0.68 acre.
