**ORDINANCE NO. 11 - 07**

**AN ORDINANCE ANNEXING INTO THE BOUNDARIES  
OF THE CITY OF CAMPBELLSVILLE, KENTUCKY,  
A CERTAIN TRACT OR PARCEL OF LAND LYING IN TAYLOR  
COUNTY BELONGING TO WELBY AND JEFF SIMPSON**

The City of Campbellsville has received a written request (consent) for annexation of the property described below, thereby eliminating the requirement of a proposed Ordinance for annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMPBELLSVILLE, KENTUCKY AS FOLLOWS:

Pursuant to the provisions of KRS Chapter 81A, the City Council of the City of Campbellsville, Kentucky, does hereby annex into the boundaries of the City of Campbellsville, Kentucky, the below-described property; and further, the City Council does hereby declare that the annexation is desirable to the needs of the City of Campbellsville, Kentucky; and, further, the City Council does hereby state that the area annexed is urban in character and that prior to the annexation it was an unincorporated territory.

Beginning at a point in the west right-of-way line of South Columbia Avenue (Deed Book 204, Page 827, City of Campbellsville) and corner of property now or formerly owned by Oneta Roberts; thence with the west right-of-way of South Columbia Ave and an existing city boundary line (Ordinance 10-06) South 37 degrees 56 minutes 07 seconds West 381.39 feet to a point in the line of Kentucky Highway 55 thence with the east right of way line of Kentucky Highway 55 as follows: North 07 degrees 53 minutes 55 seconds West 215.00 feet, North 06 degrees 21 minutes 25 seconds West 281.36 feet to the corner of Steve McKinney property (Deed Book 234, Page 401) thence with a line of said McKinney property and then with said Roberts property South 56 degrees 59 minutes 10 seconds East 352.00 feet to the beginning containing 1.55 acres.

The above description is taken from the deeds of Welby Simpson and Jeff Simpson as recorded in Deed Book 159, Page 322 and Deed Book 159, Page 324, City of Campbellsville Ordinance 10-06 and Kentucky Highway 55 right of way (City of Campbellsville Ordinance 08-03).

The above description is for annexation purposes only and is not to be used for land transfer.


The property annexed hereby shall be zoned B4.





**ANNEXATION DESCRIPTION FOR WELBY SIMPSON AND JEFF SIMPSON**



Beginning at a point in the west right-of-way line of South Columbia Ave. (Deed Book 204, Page 827, City of Campbellsville) and corner of property now or formerly owned by Oneta Roberts; thence with the west right-of-way of South Columbia Ave and an existing city boundary line (Ordinance 10-06) South 37 degrees 56 minutes 07 seconds West 381.39 feet to a point in the line of Kentucky Highway 55; thence with the east right-of-way line of Kentucky Highway 55 as follows; North 07 degrees 53 minutes 55 seconds West 215.00 feet, North 06 degrees 21 minutes 25 seconds West 281.36 feet to the corner of Steve McKinney property (Deed Book 234, Page 401) thence with the line of said McKinney property and then with said Roberts property South 56 degrees 59 minutes 10 seconds East 352.00 feet to the beginning containing 1.55 acres.


