AN ORDINANCE ANNEXING INTO THE BOUNDARIES
OF THE CITY OF CAMPBELLSVILLE, KENTUCKY, A CERTAIN
TRACT OR PARCEL OF LAND LYING IN TAYLOR
COUNTY BELONGING TO CITY OF CAMPBELLSVILLE, KENTUCKY

The City of Campbellsville has received a written request (consent) for annexation of the property described below, thereby eliminating the requirement of a proposed Ordinance for annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMPBELLSVILLE, KENTUCKY AS FOLLOWS:

Pursuant to the provisions of KRS Chapter 81A, the City Council of the City of Campbellsville, Kentucky, does hereby annex into the boundaries of the City of Campbellsville, Kentucky, the below-described property; and further, the City Council does hereby declare that the annexation is desirable to the needs of the City of Campbellsville, Kentucky; and, further, the City Council does hereby state that the area annexed is urban in character and that prior to the annexation it was an unincorporated territory.

Beginning at a point on the east side of Kentucky Highway 210 and being in the line of the existing City of Campbellsville boundary per Ordinance dated: April 20, 1981; thence with lines of said Ordinance dated April 20, 1981 as follows: North 40 degrees 56 minutes 00 seconds West 226.13 feet; North 49 degrees 36 minutes 25 seconds East 397.30 feet; thence with the property now or formerly owned by George W. Cerezo and then with the property now or formerly owned by John Humphress as follows:, North 70 degrees 52 minutes 11 seconds East 613.13 feet; North 64 degrees 52 minutes 11 seconds East 610.00 feet; thence South 68 degrees 28 minutes 11 seconds East 328.00 feet; thence with the lines of existing Ordinance No. 99-001, and then with property now or formerly property owned by Campbellsville University as follows: South 62 degrees 07minutes 29 seconds West 247.48 feet; South 62 degrees 02 minutes 37 seconds West 235.15 feet; South 59 degrees 15 minutes 10 seconds West 340.97 feet; South 57 degrees 27 minutes 31 seconds West 215.34 feet; South 67 degrees 49 minutes 00 seconds West 243.00 feet; South 71 degrees 00 minutes 24 seconds West 491.80 feet to the beginning containing 11.56 acres.


