#### **ORDINANCE NO. 12-14**

## AN ORDINANCE ANNEXING INTO THE BOUNDARIES OF THE CITY OF CAMPBELLSVILLE, KENTUCKY, A CERTAIN TRACT OR PARCEL OF LAND LYING IN TAYLOR COUNTY BELONGING TO M & W LAND DEVELOPMENT

The City of Campbellsville has received a written request (consent) for annexation of the property described below, thereby eliminating the requirement of a proposed Ordinance for annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMPBELLSVILLE, KENTUCKY AS FOLLOWS:

Pursuant to the provisions of KRS Chapter 81A, the City Council of the City of Campbellsville, Kentucky, does hereby annex into the boundaries of the City of Campbellsville, Kentucky, the below-described property; and further, the City Council does hereby declare that the annexation is desirable to the needs of the City of Campbellsville, Kentucky; and, further, the City Council does hereby state that the area annexed is urban in character and that prior to the annexation it was an unincorporated territory.

A certain tract of land located at the east limits of Campbellsville, Taylor County, Kentucky, and being more particularly described as follows:

Beginning at a point near the west end of Garden Way and near the north right-of-way line of U. S. Highway 68 and corner of the Terry Pennington property (Deed Book 246, Page 388) and being a corner of the existing City of Campbellsville boundary (Ordinance 97-002); thence with the line of said Pennington property North 40 degrees 15 minutes 09 seconds West 300.00 feet to a point; thence with the lines of the M & W Land Development, LLC property and with the existing City of Campbellsville boundary (Ordinance 97-001) as follows: North 54 degrees 18 minutes 46 seconds East 188.00 feet; South 41 degrees 47 minutes 34 seconds East 279.00 feet to a point on the north side of said Garden Way; thence with the north side of said Garden Way South 47 degrees 56 minutes 39 seconds West 195.00 feet to the beginning containing 1.27 acres.

The above description is based on a survey by M.C. Young as recorded in Deed Book 160, Page 409 and also a survey of nearby properties by Robert L. Miller, Jr. in 2000.
