AN ORDINANCE ANNEXING "GOWDYTOWN" INTO THE CITY OF CAMPBELLSVILLE, KENTUCKY.

4.

WHEREAS, the Campbellsville Housing and Community Development Agency and various persons within the hereinafter described area have petitioned the Planning & Zoning Commission of the City of Campbellsville, Kentucky, for annexation of their properties into the City of Campbellsville, Kentucky; and

WHEREAS, the Planning & Zoning Commission of the City of Campbellsville, Kentucky, pursuant to KRS Chapter 100, has held a public hearing on the question, which said public hearing was held on the 12th day of April, 1979; and

WHEREAS, the Planning & Zoning Commission has formally recommended to the Common Council that the hereinafter described area be annexed into the City of Campbellsville without a zoning designation at the present time;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF CAMPBELLSVILLE, KENTUCKY, AS FOLLOWS:

That the hereinafter described land:

On the North a line South of Broadway from Baptist Street to a line parallel with Ingram Avenue.

On the East from a line parallel to Ingram to the South side of the Louisville & Nashville Railroad tract to an area which would include one parcel beyond Roberts Road (H. R. Richardson property) to the property line of Mrs. Nora Richardson.

On the South from a line immediately south of the cemetery to the West side of Industrial Road, then along Buckhorn Creek to Roberts Road. The South boundaries shall not include any parcels owned by Ingersoll-Rand, Campbellsville Industries or Parker-Kalon Company.

On the West, present city limits.

Be, and hereby is, annexed into and made a part of the City of Campbellsville, Kentucky; and further, that the area, because of the development plans pending for the area, be unzoned at the present time.

This Ordinance was introduced and given first reading and passage at a meeting of the Common Council of the City of Campbellsville, Kentucky, held on April 16, 1979; it received second reading, passage and became effective at the next meeting of said Council on the 7th day of May, 1979.
