The City of Campton was incorporated in 1870 and is a sixth class City.


Boundries are as follows;

One Square Mile.

Begining at a stake one half mile East of Courthouse in said town,
Thence South one half mile, Thence West one mile, Thence North one mile,
Thence East one mile, Thence South to the beginning.

The following Annex to City in 1977 on North End;

Beginning on the East side of North Washington Street at the Land
Line of William Buchanan; Thence an Eastward Course with the William
Buchanan line to a corner; thence turning a Southward Course and running
with the William Buchanan Line to the C.P.Gullett line, thence an East-
ward course with the C.P.Gullett line, up the hill to Clifford Lacy line,
thence a Northward Course with Clifford Lacy line to the land line of
Thomas Cox; Thence same course with Thomas Cox line to the Right of Way
of the Mountain Parkway, Thence a Westward Course with the Mountain Park-
way right of way to opposite of Wolfe Lake Dam, Thence crossing the
Right of Way of the Mountain Parkway to the Right of Way line of Common-
wealth of Kentucky Wolfe Lake Dam property; Thence a Northward course
with the said Commonwealth of Kentucky Wolfe Lake Property Line to
Hirams Branch, Thence a Westward Course with Hiram's Branch to the High-
way, Thence with the Highway Southward to the Right of Way of the Moun-
tain Parkway; Thence continuing Southward and crossing the said Right of
Way: Thence continuing Southward Course with Highway or North Washington
Street to place of beginning.
