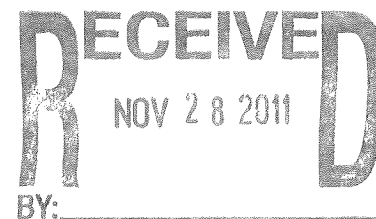

ORDER ON FINAL JUDGMENT

On April 27, 2011 Judgment was entered in this Court voiding the November 4, 2010 Election for Mayor of Cave City, Kentucky. The Judgment declared a vacancy in the Office of Mayor and directed that the vacancy be filed by the city council and that the person named serve as mayor until the next general election, which at that time was November 8, 2011. The Judgment of the Court was stayed by an appeal to the Kentucky Court of Appeals. The Court's Judgment was affirmed by the Court of Appeals on September 7, 2011. The Kentucky Supreme Court was petitioned, seeking discretionary review. This request was denied by Order of the Supreme Court of November 16, 2011. This Order Denying Discretionary Review is effective upon entry (Cr 76.38). This Court's Judgment of April 27, 2011 is no longer stayed and a vacancy therefore exist in the Office of Mayor of Cave City.

Pursuant to KRS 83A.040, this vacancy shall be filled by the city council within thirty (30) days. The person selected by the city council shall serve until the post is filled by election. Pursuant to Section 152 of the Constitution of Kentucky, a special election to fill the balance of the four (4) year unexpired term shall be held at the next general election, which is November 6, 2012. The person elected in the November 2012 Election shall immediately take office as soon as the election result is certified by the Barren County Board of Elections. That person shall serve the balance of the four (4) year unexpired term.
