WHEREAS, the City of Central City, Kentucky is the owner of, or is in the process of acquiring the territory hereinafter more particularly described; and

WHEREAS, it is desirable to incorporate said territory, which contains the Wastewater Treatment Plant for the City of Central City, Kentucky, into the city limits of the City of Central City, Kentucky; and

WHEREAS, a map of said area proposed to be annexed into the city limits of the City of Central City, Kentucky, has now been received; and

WHEREAS, the Joint City-County Planning and Zoning Commission has held its public hearing pursuant to KRS 81A.420, as more particularly set out hereinafter; and

WHEREAS, the territory proposed to be annexed is contiguous to the City's current boundaries and is urban in nature.

corner of the Central City Wastewater Treatment Plant site, same located 5.16 feet from a steel corner fence post; thence with the line of same S 73°50'25" E 575.00 ft. to a point; thence with same and running along the East side of the Wastewater Plant access road S 10°24'35" W 825.59 ft. to an iron pin and cap marked LS 2474 in the North right of way of Whitmer Street (also known as Fairgrounds Road); thence crossing Whitmer Street (also known as Fairgrounds Road) S 10°24'35" W 40.17 ft. to the beginning, containing 11.408 acres more or less, according to a survey conducted under the direction of Frank J. Kondracki, Jr., RLS No. 2474, during the month of September, 1988.

2. The Joint City-County Planning and Zoning Commission has held its public hearing pursuant to KRS 81A.420 and has recommended that the territory described above proposed to be annexed be zoned M-1 "Light Industrial", and therefore it is proposed that said territory proposed to be annexed, described above and in the attached map or plat, shall be zoned M-1 "Light Industrial".

This annexation proposal Ordinance shall be effective upon its passage, approval, and publication as required by law.




