ORDINANCE #89-22

AN ORDINANCE ANNEXING AN AREA OF CENTRAL CITY TO BE KNOWN AS THE "BROWNIE ROAD ANNEXATION"

WHEREAS, said annexation proposal ordinance was published pursuant to law on 7/19/89 + 9/6, 1989; and

WHEREAS, no petition has been received by the Mayor in opposition to said proposed annexation, pursuant to Kentucky Revised Statute 81A.420; and

WHEREAS, more than sixty (60) days have elapsed since the publication date of said annexation proposal ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CENTRAL CITY, KENTUCKY, AS FOLLOWS:

1. That the following described area is hereby annexed into the City Limits of the City of Central City, Kentucky, and shall henceforth be a part of the City of Central City, Kentucky:

Beginning at a iron pin (set) in the north right of way of Brownie Road, being North 57-00-00 East 331.78 feet from the intersection of the north right of way of Brownie Road with the east right of way of South Ninth Street, said beginning corner is in the east line of the present corporate limits of Central City; and is the corner between Tracts No. 1 and 2 of John Bratcher; thence North 33-00-00 West 220.00 feet with the line of John Bratcher, Tract 2, and later Willa Dean Martin, to an iron pin (set) corner to Central Land Company; thence North 57-00-00 East 200.00 feet with the line of Central Land Company to an iron pin (set); thence South 33-00-00 East 220.00 feet with the line of Central Land Company to an iron pin (set) in the north right of way of Brownie Road; thence South 57-00-00 West 200.00 feet with said right of way to the beginning containing 1.01 acres pursuant to a March 23, 1989 survey by William C. Hill, L.S. 2102.

Said territory is shown in a map or plat attached hereto and made a part hereof by reference; said map or plat was prepared by William C. Hill, L.S. 2102, and is dated March 17, 1989.

2. Pursuant to the recommendation of the Joint City-County Planning and Zoning Commission, and KRS 81A.420, the above described annexed territory shall be zoned "R-2", and an appropriate map amendment to the City's zoning map shall be made pursuant to this ordinance.
