## ORDINANCE #89-21

## AN ORDINANCE ANNEXING AN AREA OF CENTRAL CITY TO BE KNOWN AS THE "WHITMER STREET PUMP STATION ANNEXATION"

WHEREAS, Ordinance #89-10 (KOC # 1/0.21) was passed and approved by the City Council of the City of Central City, Kentucky, on July 12, 1989, which Ordinance was an annexation proposal ordinance; and

WHEREAS, said annexation proposal ordinance was published pursuant to law on 1/19/89 + 9/6/89, 1989; and

WHEREAS, no petition has been received by the Mayor in opposition to said proposed annexation, pursuant to Kentucky Revised Statute 81A.420; and

WHEREAS, more than sixty (60) days have elapsed since the publication date of said annexation proposal ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CENTRAL CITY, KENTUCKY, AS FOLLOWS:

1. That the following described area is hereby annexed into the City Limits of the City of Central City, Kentucky, and shall henceforth be a part of the City of Central City, Kentucky:

Description of property owned by the City of Central City, located on Fairgrounds Road.

Beginning at a point where the North right of way of Fairgrounds Road intersects the center of Little Cypress Creek, corner to Peabody Coal Company; thence with the north right of way of Fairgrounds Road South 69-38-44 East 16.48 feet to an iron pin (set) on the east bank of Little Cypress Creek; thence continuing with said right of way South 69-38-44 East 377.42 feet to an iron pin (set); thence still with said right of way South 74-28-09 East 60.20 feet to an iron pin (set), corner to Albon King; thence North 19-00-00 East 689.40 feet with King's line to an iron pin (set) in the center of a ditch in the line of Blanche Shown; thence with Blanche Shown's lines the following calls: South 84-50-00 West 66.70 feet, North 85-20-00 West; North 59-09-00 West 100.40 feet, South 87-30-00 West 71.30 feet, North 78-03-00 West 95.50 feet to a point in the center of Little Cypress Creek, said point being North 43-21-40 West 17.64 feet from an iron pin set on the Creek bank as a reference monument; thence with the line of Peabody Coal Company; South 22-46-43 West 616.77 feet to the beginning, containing 6.43 acres pursuant to a March 17, 1989, survey by William C. Hill, L.S. 2102.

Said territory is shown in a map or plat attached hereto and made a part hereof by reference; said map or plat was prepared by William C. Hill, L.S. 2102, and is dated March 17, 1989.

Being the same property conveyed to the City of Central City by Blanche Shown and wife, Katie Shown, by deed dated May 26, 1949, and of record in the Office of the Muhlenberg County Clerk in Deed Book 194, Page 47.

- 2. Pursuant to the recommendation of the Joint City-County Planning and Zoning Commission, and KRS 81A.420, the above described annexed territory shall be zoned "M-1", "Light Industrial", and an appropriate map amendment to the City's zoning map shall be made pursuant to this ordinance.
- 3. The City Clerk of the City of Central City, Kentucky, shall cause a certified copy of this Ordinance to be filed with the Muhlenberg County Clerk and with the Kentucky Secretary of State for recording in said Offices.
- 4. This Ordinance shall take effect upon its passage, approval, and publication as required by law.
