ORDINANCE #97-

AN ORDINANCE ANNEXING AN AREA OF THE CITY OF CENTRAL CITY, KENTUCKY, TO BE KNOWN AS THE 1997 HIGHWAY #189 BYPASS ANNEXATION

WHEREAS, the owners of the hereinafter described real estate have consented and requested in writing that said real estate owned by them, consisting of one tract hereinafter more particularly described in Exhibit "A", be annexed into the City of Central City, Kentucky; and

WHEREAS, because the owners of the property to be annexed have consented in writing to the annexation, pursuant to KRS 81A.412, the sixty (60) day period provided for in KRS 81A.420 does not apply;

WHEREAS, the City of Central City, Kentucky, desires to expand its territory to facilitate commercial and other growth in the area hereinafter described; and

WHEREAS, the territory proposed to be annexed is contiguous or adjacent to the City's current boundaries and is urban in character or suitable for development for urban purposes without unreasonable delay.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF CENTRAL CITY, KENTUCKY, AS FOLLOWS:

1. That the territory described in Exhibit "A" attached hereto and made a part hereof by reference, is hereby annexed into the City Limits of the City of Central City, Kentucky, and shall henceforth be a part of the City of Central City, Kentucky. Said

territory is also contained in a map or plat attached hereto and made a part hereof by reference.

- 2. Pursuant to the recommendation of the Joint City-County Planning and Zoning Commission, and KRS 81A.420 and KRS 100.209, the above described annexed territory shall be zoned B-2, as marked on the map or plat attached hereto and made a part hereof by reference, and an appropriate map amendment to the City's zoning map shall be made pursuant to this ordinance. The City Council has heretofore taken final action on the Muhlenberg Joint City-County Planning and Zoning Commission recommendation as to zoning, as required by KRS 100.209(1).
- 3. Pursuant to KRS 81A.470, the City Clerk of the City of Central City, Kentucky, shall cause a certified copy of this Ordinance, including the map and metes and bounds description of the annexed area, to be filed with the Muhlenberg County Clerk, with the Kentucky Secretary of State, and with the Department of Local Government for recording in said Offices.
- 4. This Ordinance shall take effect upon its passage, approval, and publication as required by law.
