AN ORDINANCE FILLING A VACANCY IN THE OFFICE OF MAYOR
CAUSED BY THE RESIGNATION OF JERRY L. MITCHELL

WHEREAS, JERRY L. MITCHELL, MAYOR OF THE CITY OF CENTRAL CITY,
SUBMITTED HIS LETTER OF RESIGNATION, EFFECTIVE AT 5:00 P.M. CDST ON MAY 12,
2010; and

WHEREAS, PURSUANT TO KRS 83A.040, IT IS THE DUTY OF THE CITY
COUNCIL TO FILL THE VACANCY CREATED BY JERRY L. MITCHELL'S RESIGNATION.

NOW, THEREFORE, IT IS ORDAINED BY THE CITY OF CENTRAL CITY,
KENTUCKY, AS FOLLOWS:

Barry Shaver is hereby elected by City Council to fill the unexpired term of
Jerry L. Mitchell, which unexpired term runs through December 31, 2010.

This is an emergency ordinance which shall take effect immediately, it
having passed by at least a two thirds (2/3) majority. The emergency consists of an
immediate need to fill the vacancy in the Office of Mayor of the City of Central City
created by the resignation of Jerry L. Mitchell as Mayor.

The City Clerk shall cause a Certified Copy of this Ordinance to be filed
with the Muhlenberg County Clerk and with the Kentucky Secretary of State, and shall
further cause it to be published according to law, all within ten days of the passage of
this ordinance.
