

ORDINANCE 1996-7  
AN ORDINANCE RELATING TO THE ANNEXATION  
OF UNINCORPORATED AREAS TO THE CORPORATE  
LIMITS OF THE CITY OF CLARKSON, KENTUCKY

WHEREAS, the City of Clarkson is a municipal corporation of the 6th class of the Commonwealth of Kentucky; and

WHEREAS, an ordinance declaring the intention of this City to annex the hereinafter described property has heretofore been duly adopted by the City Commission of the City of Clarkson, Kentucky, on June 24, 1996; and

WHEREAS, the owners of the property which is the subject matter of this annexation proceeding have requested in writing that the property be annexed by the City;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF CLARKSON, KENTUCKY, that the City of Clarkson, does hereby annex that property which is contiguous to the existing corporate limits of this city which property is described in Exhibit A, which is attached hereto and incorporated herein by reference.

PROPOSED ANNEXATION TO CITY OF CLARKSON

MANION, INC., PROPERTY:

A certain tract in the Town of Clarkson, Grayson County, Kentucky, bounded and described as follows:

BEGINNING at an iron pin in the north right of way of Old Leitchfield-E'town Road, corner to the Clarkson Cemetery; THENCE South 87 degrees 00 minutes 23 seconds West for a distance of 394.01 feet with the right of way of Old Leitchfield-E'town road to an iron pin; THENCE, continuing with the right of way line, South 75 degrees 11 minutes 04 seconds West for a distance of 322.52 feet to an iron pin; THENCE North 21 degrees 52 minutes 01 seconds West for a distance of 310.72 feet to an iron pin severing the parent tract; THENCE North 29 degrees 34 minutes 22 seconds East for a distance of 844.91 feet to an iron pin; THENCE South 71 degrees 45 minutes 00 seconds East for a distance of 482.38 feet to an iron pin; THENCE South 04 degrees 01 minutes 27 seconds West for a distance of 770.99 feet back to the point of beginning.
