This action having come on for a hearing ~~at the~~ Court, and it appearing to the Court that notices of same have been given in accordance with the order of the Court, and it further appearing to the Court, and the Court being sufficiently advised on the Petition herein, that the property within the described boundaries of said city is sufficient to meet the said requirements of law which govern the creation of Sixth (6th) Class cities, and the Court being sufficiently advised,

IT IS ORDERED AND ADJUDGED as follows:

1. That a city to be known as Coldstream, Kentucky, be and the same hereby is established as a municipal corporation of the Sixth (6th) Class city within the following described boundaries, to-wit:

Beginning at a nail at the intersection of the center-line of Ky. Highway #22 (Ballardsville Road) at the northeast corner of the Hillcrest Baptist Church tract, said point being approximately 1200 feet from the intersection of Ky. Highway #22 and Murphy Lane;

Thence with said line of Ky. Highway #22 No. 88° 50' 24" E 1151.42 feet to a nail; thence N 81° 40' 53" E 1383.99 feet to a nail; thence leaving said road with the following courses and distances, S 08° 19' 07" E 40.00 feet to a pipe, thence S 13° 49' 52" W 25.58 feet to a pipe, thence S 36° 37' 13" E 221.61 feet to a pipe, thence N 57° 34' 34" E 72.00 feet to a pipe, thence S 28° 13' 39" E 266.82 feet to a pipe, thence S 63° 29' 59" E 110.83 feet to a

pipe, thence S 21° 23' 00" E 186.12 feet to a pipe, thence S 77° 36' 35" E 123.34 feet to a pipe, thence N 83° 04' 57" E 304.50 feet to a pipe, thence N 66° 07' 47" E 84.47 feet to a pipe, thence S 23° 52' 13" E 108.16 feet to a pipe, thence S 30° 32' 50" W 39.64 feet to a pipe, thence S 55° 52' 28" 203.31 feet to a pipe, thence S 37° 48' 30" W 35.39 feet to a pipe, thence S 48° 30' 33" E 185.59 feet to a pipe, thence S 61° 55' 00" W 295.49 feet to a pipe, thence S 50° 07' 47" W 495.29 feet to a pipe, thence S 51° 14' 23" W 112.86 feet to a pipe, thence S 32° 51' 01" E 150.00 feet to a pipe, thence S 57° 08' 59" W 337.69 feet to a pipe, thence N 32° 51' 01" W 868.40 feet to a stone, thence S 70° 25' 05" W 1603.61 feet to a pipe, thence N 32° 25' 29" W 1690.76 feet to the point of beginning.

All of the Council Members and Officers above appointed, shall hold their respective offices until the next election of the officers of cities and towns may be held.

Qualifications of said officers shall be in the manner provided by law and they shall take office upon their taking their respective oaths of office and executing their respective bonds and the other obligations that may be provided by law; record of same shall be entered upon the records of said City

and copies of said record may be certified by the City Clerk as needed.

3. The Clerk of the Court, not later than ten (10) days after Judgment is entered herein shall certify a copy of this Judgment to the Secretary of State of Frankfort, Kentucky, whose duty it shall be to properly enter and file the same in the Secretary of State's office.
