ORDINANCE NO. 2007-03

AN ORDINANCE RELATING TO AMENDMENT OF  
ORDINANCE NO. 1985-11, AN ORDINANCE ANNEXING TO  
THE CITY OF COLDSTREAM A CERTAIN TRACT OF LAND

Whereas, pursuant to the provisions of the Kentucky Revised Statutes, the City of Coldstream, Kentucky was authorized and empowered to annex territory in 1985 and did so by virtue of City of Coldstream Ordinance No. 1985-11, and

Whereas, City of Coldstream Ordinance No. 1985-11 contained a technical error in the description of the territory intended to be annexed, such that the territory annexed was larger than intended, and

Whereas, it is the intention of the City of Coldstream Council to correct the description so that it reflects the territory intended to be annexed, which has been maintained as City of Coldstream territory since its annexation in 1985;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF COLDSTREAM, KENTUCKY AS FOLLOWS:

Section 1: The original text of City of Coldstream ordinance 1985-11 was as follows, with appropriate language stricken through which is hereby being deleted and with the language underlined which is being added:

"BE IT ORDAINED BY THE CITY OF COLDSTREAM: that as no protests were filed within sixty days of the publication of the proposal to annex the said tract of land, the City of Coldstream hereby annexes and incorporates into the City of Coldstream and hereby extends the boundaries of the City of Coldstream to include the same tract of land now enframed in the unincorporated County of Jefferson and which is adjacent to and contiguous with the present City boundaries for all purposes as regulated by the City Plan and Constitution. Said tract of land is more particularly described as follows, to wit:

~~Beginning at a nail at the intersection of the centerline of Ky. Highway No. 22 (Ballardsville Road) at the northeast corner of the Hillcrest Baptist Church tract, said point being approximately 1200 feet from the intersection of Ky. Highway No. 22 and Murphy Lane, thence leaving said road with the following courses and distances comprising the west line of Coldstream S 32° 25' 28" E 1690.76 feet to a pipe; thence S 70° 25' 05" E 1603.64 feet to a stone; thence S 32° 51' 01" E 868.40 feet to a pipe in the south line of Coldstream which is of record in Plat and Subdivision Book 33, page 72 in the Office of the Clerk of the County Court of Jefferson County, Ky.~~

~~The area to be annexed by the City of Coldstream is enclosed by the following courses and distances from said pipe in the south line of Coldstream, S 32° 51' 01" E 1730.57 feet. to a post corner; thence South 71° 48' 00" E 718.83 feet to a pipe corner to Dewey~~

~~M. Keys tract; thence following the west line of Lake Louisvillia tract N 09° 43' 06" E 126.70 feet to a pipe; thence N 12° 57' 05" E 948.45 feet to a pipe; thence N 05° 10' 18" E 397.32 feet to a pin; thence departing said Lake Louisvillia tract with the following courses and distances, N 37° 15' 00" W 1585.00 feet to a pipe in the south line of Coldstream; thence following said line S 61° 55' 00" W 295.49 feet to a pipe; thence S 50° 07' 47" W 495.29 feet to a pipe; thence S 51° 14' 23" W 112.86 feet to a pipe; thence S 32° 51' 01" E 150.00 feet to a pipe; thence S 57° 08' 59" W 337.69 feet to the point of beginning in the south line of Coldstream.~~

This ordinance 1985-11 shall take effect upon its passage, approval and publication as required by law.
