## ORDINANCE # 1-2016

AN ORDINANCE CORRECTING AN ORIGINAL KRS 81.045 FILING WHERE A PORTION OF PROPERTY WAS ERRONEOUSLY SHOWN AS ANNEXED AND SEVER THAT PORTION OF PROPERTY TO CORRECT THE BOUNDARY LINE.

WHEREAS, the City of Corbin, Kentucky, (hereafter the "City"), submitted a boundary statement and other information in compliance with KRS 81.045 approved June 23, 1981: and,

WHEREAS, an area not annexed was accidentally shown to be included in the KRS 81.045 boundary statement inasmuch as the map submitted was prepared in 1978 and the city failed to make a correction to the map to exclude the hereinabove referenced submittal when the KRS 81.045 filing was approved by the Secretary of State's Office in 1981; and,

WHEREAS, the submitted map was not challenged or overturned in court or in an election process; and,

WHEREAS, the City further wishes to provide a modern legal description and revised plat for the purposes of showing the location of the prior June 23, 1981 approval to be severed, same having been prepared by a professional land surveyor for the purpose stated therein; and,

WHEREAS, the City wishes to correct its KRS 81.045 filing and comply with the requirements of Amended KRS 81A.470, effective July 13, 2004, and

WHERESA, with respect to the KRS 81.045 map approved June 23, 1981, the City does not intend to replace its prior ordinance annexing, but rather to interpret the defined boundaries of the territory previously shown annexed and adopt a modern legal description of territory to be severed; and,

Whereas, THE City wishes to sever the modern legal description of the territory previously shown annexed to its KRS 81.045 filing, thereby correcting same,

NOW THEREFORE, be it ordained by the Board of Commissioners of the City of Corbin, Kentucky (the "City") as follows:

- 1. The City adopts the following legal description and plat attached hereto as prepared by James D. Blanton, Licensed Professional Land Surveyor No.3409 for the purposes stated therein, as a modern description of the property previously listed as a part of the corporate city limits of the City by KRS 81.045 map approved June 23, 1981, and hereby adopts said new legal description and plat as the official legal description and plat to be severed by the city for all purposes when referencing the Official City of Corbin, Kentucky Zone Map.
- 2. The new legal description as prepared by James D. Blanton, Licensed Professional Land Surveyor No. 3409 for the purposes stated therein, is as follows:

- 3. This ordinance and the attached documents shall be filed with the Office of the Secretary of State to correct the City's KRS 81.045 filing.

THE ONLY FIELD SURVEYING PERFORMED ON THIS PROJECT WAS GPS CONTROL POINTS WERE SET AND GROUND SURVEYING TO EACH PARCEL AND THE LOCATION OF AT LEAST 2 OF THE CORNERS CALLED FOR IN THE SURVEY INFORMATION (OR ADJACENT OR NEARBY ANNEXATIONS) AND MAY OR MAY NOT BE NOTED IN THE SURVEYORS CERTIFICATION AND THEN A ROTATION APPLIED.
