ORDINANCE NO. 1-88

AN ORDINANCE ANNEXING TO THE CITY OF CORBIN, KENTUCKY, A CERTAIN TRACT OF REAL ESTATE IN THE COUNTY OF KNOX, SAID TRACT BEING MORE PARTICULARLY HEREINAFTER DESCRIBED.

WHEREAS, the first reading of Ordinance No. 17-87 declaring an intent to annex the following described property was read and passed on October 5th, 1987, and the second reading and passage of said Ordinance was October 19th, 1987, and said Ordinance No. 17-87 was properly advertised and the residents or owners of real property within the limits of the real estate proposed to be annexed have not petitioned the Mayor in opposition to the proposed annexation, and

WHEREAS, the said real estate is contiguous to the City's present boundaries, and WHEREAS, the said real estate is suitable for development for urban purposes without unreasonable delay, and

WHEREAS, the City of Corbin, Kentucky, desires to annex the hereinafter described real estate. BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF CORBIN, KENTUCKY AS FOLLOWS: SECTION I: The following described real estate is hereby annexed to the City of Corbin, Kentucky, extending the boundaries of the City of Corbin, Kentucky, to include the same, that certain tract of real estate which is now embraced within the County of Knox and which is adjacent to and contiguous with the present City boundary line, and is more particularly described, as follows, to-wit:

> Beginning at a stone on the south corner of lot, the stone being located between the branch and Highway 25-E; thence following Highway 25-E in a westward direction 375 feet to a Branch; thence following the meanders of the branch a southward direction 425 feet to the Beginning.

Being the same property acquired by Larry Woodlee and wife, Linda Woodlee, by deed dated November 19, 1986, which is duly recorded at Deed Book 229, Page 620, Knox County Court Clerk's Office, and the same property in which Paul Fultz and wife, Mable Fultz, acquired a one-half (1) interest by deed of conveyance dated November 22, 1986, which is duly recorded in Deed Book 229, Page 623, Knox County Court Clerk's Office.

SECTION II: Immediately upon the effective date hereof, the City Clerk is hereby authorized and directed to publish and advertise this Ordinance as required by Chapter 424 of the Kentucky Revised Statutes.

RESOLUTION NO. 2-88

County of Knox

Incorporated Area of Corbin

Resolution adopting and approving the execution of a Contract between the Incorporated Area and the Department of Rural and Municipal Aid, Commonwealth of Kentucky, for the fiscal year beginning July 1, 1988, as provided in the Kentucky Revised Statutes and accepting all streets referred to therein as being streets which are a part of the Incorporated Area.

BE IT RESOLVED BY THE LEGISLATIVE BODY OF THE INCORPORATED AREA THAT:

Section 1:

1

The Legislative Body of the Incorporated Area does hereby accept all streets referred to in said Contract as being city streets which are a part of the Incorporated Area; and

The Legislative Body of the Incorporated Area does hereby ratify and adopt all statements, representations, warranties, covenants, and agreements contained in said Contract and does hereby accept said Contract and by such acceptance agrees to all the terms and conditions therein stated.

Said Contract read as follows:

THIS CONTRACT is made between the Department of Rural and Municipal Aid, Commonwealth of Kentucky, and the Legislative Body of the Incorporated Area of Corbin, Knox County, Kentucky.

The initial apportionment to the Incorporated Area for the fiscal year beginning July 1, 1988, less three (3) percent set aside for an emergency fund, is seventy-nine thousand three hundred sixty-eight and no one-hundredths dollars (\$79,368.00). This amount, when added to any subsequent apportionments and any unencumbered balance of prior apportionments to the said Incorporated Area will be expended by the Kentucky Department of Rural and Hunicipal Aid to aid the Incorporated Area in the maintenance, reconstruction, or construction of streets in said Incorporated Area.

The Legislative Body of the Incorporated Area hereby agrees and directs that their prorata share of the Municipal Aid Fund, due monthly from the Finance Cabinet, in accordance with KRS 177.366, be assigned to the Transportation Cabinet's Division of Accounts for Fiscal Year 1988-89.

Unless specifically excluded within this contract, all streets are a part of this contract. This includes all structures lying within the limits of the project.
