Highway 25-E, on the north side of a 40-foot street, recently named McKowan Street; thence N. 68 E. 60 feet to a stake; thence N. 22 W. 100 feet to a stake; thence S. 68 W. 60 feet to a stake; thence S. 22 E. 100 feet to a stake, the beginning corner, being on the east side of the second tract described below.

Second Tract: Beginning on a stake 177 feet east of the east line of U. S.
