## RESOLUTION NO. 5-92

RESOLUTION OF THE CITY OF CORBIN, AUTHORIZING THE FILING OF A FINAL REVISED ECONOMIC DEVELOPMENT ADMINISTRATION APPLICATION.

WHEREAS, it is necessary and in the public interest that the Applicant avail itself of the financial assistance provided by the Economic Development Administration, Department of Commerce, authorized by the Public Works and Economic Development Act of 1965, whose objective is to promote long-term economic development and assist in the construction of public works and development facilities needed to initiate and encourage the creation or retention of permanent jobs in the private sector in areas experiencing severe economic distress, and,

WHEREAS, it is recognized that the contract for such financial assistance will impose certain obliqations and and responsibilities upon the applicant and will require, among other things, the following:

- 1. Approval of a satisfactory application transmitted to the Economic Development Representative for the State of Kentucky,
- Certification by the Applicant relating to activities such as civil rights, citizen participation, relocation, acquisition of properties, national environmental policies, historic preservation policies, and account practices;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF CORBIN AS FOLLOWS:

- 1. That the United States of America and the Commonwealth of Kentucky be, and hereby are assured of full compliance by the Applicant with certification relating to all regulations and administration of civil rights act, citizen participation, relocation payments, acquisition processes, accounting procedures, the Hatch Act, minimum wage and minimum hour provisions of the Fair Labor Standards Act, and all requirements of the National Environmental Policy Act of 1968.
- 2. That the City of Crobin is eliqible to receive grant funds from the Kentucky Economic Development Bond program in the amount of \$160,000 and will make available these funds for use in the project.
- 3. That the City has received approval for 539,500 of Community Development Block Grant Funds and will make available to SEKRI a 532,000 5-year forgivable loan for the nurchase of the 10 acre tract of land at the Tri-County Industrial Park and working capital.
- 4. That the Applicant may apply for and receive a grant from the Economic Development Administration for up to \$487,000 for use in the construction of a 30,000 sq. ft. manufacturing facility.
- 5. That the Mayor is authorized and directed to prepare any such certifications and assure full compliance with all certifications as outlined above and all other pertinent regulations,

The Mayor is hereby authorized to execute and fule such applications, to provide any additional information, and to furnish such documentation as may be menuired, and to act as the authorized correspondent of the Applicant relating to the Small Business Admin-
