AN ORDINANCE ANNEXING TO THE CITY OF CORBIN, KENTUCKY, A CERTAIN TRACT OF REAL ESTATE IN THE COUNTY OF WHITLEY, SAID TRACT BEING MORE PARTICULARLY HEREINAFTER DESCRIBED.

WHEREAS, the first reading of Ordinance No. 16-86 declaring an intent to annex the following described property was read and passed on July 21, 1986 and the second reading and passage of said Ordinance was July 24, 1986, and said Ordinance No. 16-86 was properly advertised and the residents or owners of real property within the limits of the real estate proposed to be annexed have not petitioned the Mayor in opposition to the proposed annexation, and

WHEREAS, the said real estate is contiguous to the City's present boundaries, and WHEREAS, the said real estate is suitable for development for urban purposes without unreasonable delay,

WHEREAS, the City of Corbin, Kentucky, desires to annex the hereinafter described real estate.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF CORBIN, KENTUCKY, AS FOLLOWS:

SECTION I: The following described real estate is hereby annexed to the City of Corbin, Kentucky, extending the boundaries of the City of Corbin, Kentucky, to include the same, that certain tract of real estate which is now embraced within the County of Whitley and which is adjacent to and contiguous with the present City boundary line, and is more particularly described, as follows, to-wit:

Beginning on a chestnut oak, corner of James Godsey's land on a point above his house; thence S. 78 E. 64 poles to two white oaks; thence S. 15 E. 22 poles to three forked chestnuts, Ward Hosher corner; thence S. 5 W 62 poles to two chestnut oaks standing on the center of the point of end of ridge; thence running back northwestern course down center of ridge with the dividing waters to a poplar corner of W. C. Ridner's line; thence with W. C. Ridner's line to a pine, corner of James Godsey's and W. C. Ridner's; thence to the beginning. Also a quitclaim right to a right of way running from the said land to the county road north of James Godsey's house as was located from James Godsey by C. B. Skinner.

Being the same land conveyed to Danny R. Crawford, a single person, by First National Bank and Trust Company of Corbin by deed dated July 22, 1985, which is duly recorded at Deed Book 310, Page 372-373, Whitley County Court Clerk's Office.

## ORDINANCE NO. 21-86

AN ORDINANCE IMPOSING A LICENSE TAX OR FEE UPON MOTOR VEHICLES OWNED OR OPERATED WITHIN THE LIMITS OF THE CITY OF CORBIN, KENTUCKY; REQUIRING ALL PERSONS OR ENTITIES OWNING OR OPERATING SAME TO FIRST OBTAIN A LICENSE THEREFOR, AND REGULATING AND IMPOSING PENALTY FOR VIOLATION

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF CORBIN, LENTUCKY, AS FOLLOWS:

SECTION I. For the period beginning January 1, 1987 and ending December 31, 1987, the following license tax or fee is hereby levied and imposed upon motor vehicles operated by a citizen of the City of Corbin or by any person or entity doing or transacting business within the limits of the City of Corbin, Kentucky, as hereinafter provided. Said license fee or tax shall be paid into the general revenue fund of the City of Corbin. Before any person or entity shall operate any motor vehicles in said City, such person or entity shall first procure a license so to do and pay the license fee as follows:

SECTION II. A. For each automobile or truck run by motor power and owned or operated by a citizen of the City of Corbin or owned and operated by a person or entity doing or transacting business within the limits of said City escept as provided in Section III herein, a fee of \$15.00 shall be paid per annum for each such machine.

B. For each motorcycle, motorbike or any other motor driven vehicle with two or three wheels, owned or operated by a citizen of the City of Corbin or owned or operated by a person or entity doing or transacting business within the limits of said City except as provided in Section III, herein, a fee of \$7.50 shall be paid per annum for each such machine.

SECTION III. For the period beginning January 1, 1987, and ending December 31, 1987, any dealer engaged in the business of selling new and/or used motor vehicles may purchase a dealer license which may be used for any motor vehicles owned by such automobile dealer. The automobile dealer shall be entitled to five (5) permits for no additional charge and these permits may be freely transferred to any vehicle owned by the dealer. The fee for such dealer shall be Seventy Five Dollars (\$75.00) and each additional permit over five, Fifteen Dollars (\$15.00) each.

SECTION IV. All persons or entities residing outside the City limits and operating or causing to be operated any automobile, truck or motor vehicle upon and over the streets of the City of Corbin for more than five (5) days during any thirty (30) day period in connection with a business conducted or regular conveyance to and from a position, job or labor from which renumeration is received, whether such position, job or labor is performed within or without the corporate limits of the City or occupying a dwelling unit located within the City for more than five (5) days during any thirty (30) day period, shall be deemed to be doing "or transacting business in the City of Corbin.
