ORDINANCE NO. 8-95

AN ORDINANCE OF THE CITY OF CORBIN, KENTUCKY, ANNEXING TO THE CITY LIMITS OF CORBIN A CERTAIN TRACT OF PROPERTY BELONGING TO BACON CREEK BAPTIST CHURCH, INCORPORATED, HAVING AN ADDRESS OF BACON CREEK ROAD, CORBIN, WHITLEY COUNTY, KENTUCKY.

WHEREAS, the owners of certain real property in Whitley County, Kentucky, namely Bacon Creek Baptist Church, Incorporated, have petitioned in writing to the Board of Commissioners of the City of Corbin that their property located at Bacon Creek Road, Corbin, Whitley County, Kentucky, commonly known as the Bacon Creek Baptist Church, be annexed and incorporated into the City of Corbin; and

WHEREAS, said property is adjacent and contiguous to the present City boundaries; and

WHEREAS, said property is suitable for development for urban purposes; and

WHEREAS, said property meets the criteria set forth in KRS 81A.410.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the City of Corbin, Kentucky, as follows:

SECTION ONE. That pursuant to KRS 81A.412 the property of Bacon Creek Baptist Church, Incorporated, with an address of Bacon Creek Road, Corbin, Whitley County, Kentucky, is hereby annexed to the City of Corbin, and said property being more particularly described as follows:

BEGINNING on a set stone on the west side of Bacon Creek Road, thence S. 83 W. 173 feet to a set stone on the east bank of Bacon Creek; thence N. 4-1/2 W. 393-2/3 feet to a set stone; thence N. 13-1/2 E. 230 feet to a stake at the Bridge; thence with the Bacon Creek Road S. 47 E. 59 feet; thence S. 37 E. 32 feet; thence S. 21 E. 50 feet; thence S. 13 E. 150 feet; thence S. 5 E. 200 feet; thence S. 11 E. 141 feet to the beginning.

Being the same property acquired by Bacon Creek Baptist Church, Incorporated, from James Scott Roaden, et ux, by deed of conveyance of record in Deed Book 375, Page 55, Whitley County Court Clerk's Office.

SECTION TWO. This Ordinance shall take effect upon passage and advertisement.
