ORDINANCE NO. 6-98

AN ORDINANCE OF THE CITY OF CORBIN, KENTUCKY, ANNEXING TO THE CITY LIMITS OF CORBIN, KENTUCKY, CERTAIN TRACTS OF REAL PROPERTY AND ESTABLISHING THE ZONING CLASSIFICATIONS FOR SAID TRACTS OF REAL PROPERTY OWNED BY THE CORBIN TRI-COUNTY JOINT INDUSTRIAL DEVELOPMENT AUTHORITY, TRI-HILL, INC., AND SOUTHEASTERN KENTUCKY REHABILITATION INDUSTRIES, INC., AND SAID TRACTS INCLUDE THE REAL PROPERTY CONTAINED WITHIN THE RIGHT OF WAY OF U.S. HIGHWAY NO. 25E, THE RIGHT OF WAY OF THE CORBIN BY-PASS AND THE RIGHT OF WAY OF KENTUCKY STATE ROAD NO. 26 AND ALL TRACTS OF REAL PROPERTY ANNEXED HEREIN ARE LOCATED IN WHITLEY AND KNOX COUNTIES, KENTUCKY.

WHEREAS, the owners of record of certain tracts of real property, namely, Corbin Tri-County Joint Industrial Development Authority; Tri-Hill, Inc., and Southeastern Kentucky Rehabilitation Industries, Inc., have petitioned the Board of Commissioners of the City of Corbin, Kentucky, that their certain tracts of real property be annexed and incorporated into the City of Corbin, Kentucky; and

WHEREAS, the real property described herein will be adjacent and contiguous to the present City of Corbin, Kentucky, boundaries; and

WHEREAS, said real property meets the criteria set forth in KRS 81A.410.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the City of Corbin, Kentucky, as follows:

SECTION ONE. That pursuant to KRS 81A.412 those certain tracts of real property owned by the Corbin Tri-County Joint

Industrial Development Authority, Tri-Hill, Inc., and Southeastern Kentucky Rehabilitation Industries, Inc.; and certain tracts of real property contained within the right of way of U.S. Highway No. 25E, the right of way of the Corbin By-Pass and the right of way of Kentucky State Road No. 26, all of the foregoing real property being located in Whitley and Knox Counties, Kentucky, are hereby annexed to the City of Corbin, Kentucky, and said tracts of real property being more particularly described as follows:

SECTION TWO. That Tract I of the above-described property is hereby zoned General Business District (C-1).

SECTION THREE. That Tract II of the above-described property is hereby zoned Heavy Industrial District (I-2).

SECTION FOUR. That Tract III of the above-described property is hereby zoned General Business District (C-1).

SECTION FIVE. That the Zoning Map of the City of Corbin, Kentucky, is hereby amended to add the above-described tracts of property in SECTION ONE above to the City of Corbin, Kentucky, boundaries and to reflect the zoning classification given to said tracts of real property as set forth in SECTION TWO, SECTION THREE and SECTION FOUR above.

SECTION SIX. This Ordinance includes a map showing the zoning classifications given to the above-referenced tracts of real property annexed and zoned herein. Said map is attached hereto and marked Exhibit "A" and is hereby incorporated herein by reference. This Ordinance and the map attached hereto as Exhibit "A" can be reviewed and inspected at the office of the City Clerk of the City of Corbin, Kentucky, City Hall, 805 South Main Street, Corbin, Kentucky, Monday through Friday, from 8:00 a.m., until 4:00 p.m.
