W. Murry have until the first day of June, 1868, to pay the residue of the revenue for the year 1866; and when the same is paid, the damages assessed against said Murry, &c., shall stand released.

§ 2. This act to have effect from its passage.

CHAPTER 440.

AN ACT to incorporate the town of Corydon, in the County of Henderson.

Be it enacted by the General Assembly of the Commonwealth of Kentucky:

§ 1. That the citizens of the town of Corydon, in Henderson county, be, and are hereby, made a body politic and corporate, under the name and style of the town of Corydon, with full power to contract and be contracted with, to sue and be sued, to plead and be impleaded, to answer and be answered, and to do and perform all such acts and things, either in law or equity, as bodies politic and corporate, having perpetual succession, may rightfully do and perform. This town shall be laid off into necessary streets and alleys, and lots of convenient size; and a plat of said town, when so laid off, shall be recorded in the office of the clerk of the Henderson county court.

§ 2. The limits of said town shall be as follows, viz: Beginning at an iron pin twelve feet south, sixty-one degrees east from a stone, corner to Harrison Hancock, and in John R. Wilson's line, and also the termination of a twelve-foot alley at its junction with Sixth cross street; thence with the line of termination of Sixth cross street south twenty-nine degrees, west two poles, to an iron pin, corner to sixth Cross street; thence with the west side of Sixth cross street north sixty-one degrees, west twenty-seven poles and twenty-one and a half links, to an iron pin in the line of Sixth cross street, and corner of a twelve-foot alley, opposite the corner of lot No. 16, in the plat of the town; thence with the line of the said alley south twenty-nine degrees, west thirty-one poles and eight links, to an iron pin, corner to said alley, in the line of T. C. Hart's tract of land; thence with the said Hart's line north sixty-one degrees, west thirty-one poles and twenty-two links, to an iron pin or stake in the said Hart's line, and corner to a fifteen and a half foot alley, donated to the town as a passway by — Dickey; thence with the

line of the said fifteen and a half-foot alley, as left by the — Dickey, north twenty-nine degrees, east one hundred and fifteen poles and eleven links, to an iron pin in the line of Third main cross street; thence with the west line of Third main cross street north sixty-one degrees, west thirty-nine poles and nineteen and a half links, to an iron pin in the said Dickey's field; thence north twenty-nine degrees, east fifty-one poles and twenty-one and a half links, to an iron pin in W. A. Walton's line, and also Dr. John N. Dorsey's line and corner, to First cross street; thence south sixty-one degrees, east forty-eight poles and eighteen links, on the east side of First cross street, to an iron pin in the line of Belle street; thence with the north side of Belle street north twenty-nine degrees, east twenty-eight poles, to an iron pin in Dr. John N. Dorsey's field, and the termination of Belle street; thence south sixty-one degrees, east forty-eight poles and one half link, to an iron pin, corner to lot number twenty-nine, on the plat of the town, and which includes the residences of Charles Cooksey and Marion Hancock; thence twenty-nine degrees west, twenty-nine poles and twenty and one-half links, to an iron pin, at the termination of First cross street, and on the west side thereof, and also corner to John R. Wilson, or where the said street stops on said Wilson's land; thence with the west line of First cross street north sixty-one degrees, west four poles, to an iron pin, corner of Marion street; thence with the south line of Marion street south twenty-nine degrees, west twenty-eight poles and twenty-three links, to an iron pin in the line of Second cross street; thence with the east line of Second cross street south sixty-one degrees, east ten poles and twenty links, to an iron pin at the termination of Second cross street, and opposite the corner of a twelve-foot alley, and corner to John R. Wilson; thence south twenty-nine degrees, west passing the termination of Second cross street, and running with the south line of a twelve-foot alley one hundred and five and a half poles and six links to the beginning, containing sixty-one acres, more or less, and embraces the residences of Charles Cooksey, Marion Hancock, Isaac Fulwiler, Harrison Hancock, Dr. John N. Dorsey, W. B. Pentecost, Dr. H. S. Jones, C. L. King, S. H. Marshall, Darby Marshall, Mrs. Pritchett, B. F. Wood, Green & Overton's tobacco factory, Thomas Ash, Dr. J. N. Powell, E. M. Powell, J. E. Dixon, Wm. C. Green, Wm. Jones, Dr. Owen, and George W. Boone.

§ 3. That John N. Dorsey, Wm. H. Hancock, John R. Wilson, H. S. Jones, Dr. J. N. Powell, and B. F. Wood, be, and are hereby, appointed trustees of said town, who shall appoint one of their number president of the board,

and shall continue in office until their successors are elected.

§ 4. On the 1st Tuesday in June next, and on the same day in each succeeding year, an election shall be held in said town for the choice of six trustees; and all persons shall have a right to vote for trustees of said town who are free white male inhabitants thereof, who have attained the age of twenty-one years, and all other male persons who have attained the age aforesaid (negroes, mulattoes, and Indians excepted), who own a town lot or lots in said town. Said trustees, when elected, shall have the same powers and authority which trustees of other towns of this Commonwealth possess under the general laws regulating towns.

§ 5. They shall take the oath truly and faithfully to perform the duties enjoined on them by law as trustees. Said trustees shall meet and choose from among their number a president of the board, who shall hold his office until the next annual election, and whose duty it shall be to convene the trustees from time to time, to preside at their meetings, and to sign all ordinances and by-laws by them passed and enacted. Said trustees shall also elect a clerk, who shall continue in office for one year, whose duty it shall be to preserve and safely keep all papers belonging to, or filed with, said board, and shall attend the meetings thereof and record all their proceedings in a book to be procured by said board for that purpose, and shall sign the same as such clerk, and shall copy and certify all records and ordinances when necessary. Said trustees shall have power to appoint a treasurer, who shall keep the funds of said town safe, and pay the same over by order of said board to such person or persons as he shall be directed. Said board may require bond and security of said treasurer.

§ 6. Said trustees shall have power to assess a poll-tax on the legal tithables of said town, not to exceed one dollar and fifty cents, and levy an *ad valorem* tax on the real and personal estate within said town that is now taxed by the revenue laws of the Commonwealth, not to exceed thirty cents on each one hundred dollars' worth of property. Said trustees shall have power to appoint, annually, an assessor, who shall be sworn to the faithful and impartial discharge of his duty. It shall be the duty of said assessor to make out and furnish to the said trustees, at such time as they may appoint, lists of the taxable property of each individual in said town, with the value attached thereto, and also a list of the lots, and the value thereof, which belong to individuals who do not reside in said town. They shall also have power to appoint a collector, annually, to collect the taxes assessed on the taxa-

ble property and tithes in said town, who shall give bond and security to the trustees of said town for the faithful performance of all his duties. Said collector shall have power, if necessary, to collect and coerce the payment of all the taxes assessed by the trustees of said town by distress and sale, in the same manner as is now authorized by law in regard to sheriffs in collecting the revenue and county levy in this Commonwealth. Said trustees shall allow to said clerk, treasurer, assessor, and collector, an adequate compensation for their services.

§ 7. A police judge shall also be elected by the qualified voters of said town on the 1st Tuesday in June, 1868, and on every second year thereafter; and on the 1st Tuesday in June, 1868, and every second year thereafter, a town marshal. Said police judge shall be commissioned by the Governor; he shall have jurisdiction of all cases arising in said town for a violation of any of the ordinances thereof, and shall be entitled to the same fees, for similar services, with justices of the peace. The town marshal shall execute bond to the trustees for the faithful discharge of the duties of his office, with the usual conditions contained in a constable's bond, in such penalty as they may prescribe; he shall have the same powers and jurisdiction in said town as are conferred by law upon constables, be entitled to the same fees for similar services, and be responsible in like manner.

§ 8. Vacancies in the office of trustee may be supplied, for the remainder of the term, by appointment of those remaining; but vacancies in the office of police judge and town marshal shall be filled by an election for the remainder of the term, by the qualified voters of said town, at such time as the trustees may appoint, after at least ten days' notice thereof shall have been given by public advertisement at three of the most public places therein.

§ 9. A majority of the trustees shall constitute a quorum for the transaction of business; and, in the absence of the president elect, the trustees may choose one of their number as president *pro tem.*, whose act shall have the same force and effect as those of the president.

§ 10. The limits and boundaries of said town shall be ratified by a majority of the property-holders in said town over their signatures, which shall be recorded, along with the plat, in the office of the Henderson county court, which shall make the act of incorporation binding upon all persons within said limits, and shall fix said limits.

§ 11. Any vacancy which may occur in those offices which are of the trustees' appointment, may be supplied by them.

§ 12. The trustees may appoint their clerk elect to fill,

in addition to his own office, the offices of assessor, collector, and treasurer, or they may elect a different persons to fill each of the offices of clerk, assessor, collector, and treasurer.

§ 13. This act to take effect from and after its passage.

CHAPTER 441.

AN ACT for the benefit of James Turner, Sheriff of Perry County.

Be it enacted by the General Assembly of the Commonwealth of Kentucky:

§ 1. That James Turner, sheriff of Perry county, be allowed the further time until the first day of June, 1868, to pay over the balance of his unpaid revenue and return his delinquent list for the year 1867: *Provided, however,* That his sureties shall appear in open court and give their assent to the said extension of time at the next April term of the said Perry county court.

§ 2. This act to be in force from its passage.

CHAPTER 442.

AN ACT for the benefit of S. Parish, late Sheriff of Madison County.

Be it enacted by the General Assembly of the Commonwealth of Kentucky:

§ 1. That the Auditor of Public Accounts be, and he is hereby, required to draw his warrant upon the Treasurer for the sum of three hundred dollars in favor of Socrates Parish, late sheriff of Madison county, in order to reimburse him in that sum paid into the Treasury upon the militia delinquent list for the year 1863, when, in fact, it had never been collected in consequence of the repeal of the law imposing said fines.

§ 2. This act shall take effect from its passage.

CHAPTER 443.

AN ACT for the benefit of Common School District No. 34, in Green County.

WHEREAS, A common school was taught in district No. 34, in the county of Green, in the year 1866, but did not expire in time to be reported by the commissioner in his report to

the Superintendent of Public Instruction, whereby said district has failed to draw its part of the school fund therefor; wherefore,

Be it enacted by the General Assembly of the Commonwealth of Kentucky:

§ 1. That the superintendent be, and he is hereby, authorized and directed to draw his order on the Auditor for whatever amount would have been due said district if it had been properly reported in time; and the Auditor will pay the same over to the trustees of said school for the use and benefit thereof.

§ 2. This act to take effect from its passage.

CHAPTER 444.

AN ACT to change the place of voting in District No. 1, in Todd County.

Be it enacted by the General Assembly of the Commonwealth of Kentucky:

§ 1. That the place of voting in district No. 1, Todd county, be, and is hereby, changed from Coffman's Mill to Kirkmansville, in said district.

§ 2. This act to take effect from its passage.

CHAPTER 445.

AN ACT to change the place of voting in the Ticktown Precinct, in Montgomery County.

Be it enacted by the General Assembly of the Commonwealth of Kentucky:

§ 1. That the voting precinct in Montgomery county, No. 4, be changed from Turley's Mill to H. R. C. Greenwade's house or store in Jeffersonville.

§ 2. This act shall take effect from and after its passage.

CHAPTER 448.

AN ACT to incorporate Hinton Lodge, No. 369, of Free and Accepted Masons.

Be it enacted by the General Assembly of the Commonwealth of Kentucky:

The worshipful master, wardens, and members of Hinton Lodge, No. 369, of Free Masons, in the county of Graves, at Spence's Chapel, be, and they are hereby,
