BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF COVINGTON, KENTON COUNTY, KENTUCKY:

Section 1


That Commissioners' Ordinance No. O-44-05 which divided the City into four Wards in the City of Covington, Kentucky, is hereby repealed in its entirety effective for the 2008 General Election.

Section 2

That this ordinance shall take effect and be in full force when passed, published and recorded according to law.

COMMISSIONERS' ORDINANCE NO. 0-31-07

AN ORDINANCE REPEALING COMMISSIONERS' ORDINANCE NO. O-49-05 THAT REQUIRED A CANDIDATE FOR COVINGTON CITY COMMISSION TO BE A RESIDENT IN THE WARD HE OR SHE SEEKS TO REPRESENT NOT LESS THAN ONE YEAR PRIOR TO HIS OR HER ELECTION IN THE CITY OF COVINGTON, KENTUCKY, IN ITS ENTIRETY EFFECTIVE FOR THE 2008 GENERAL ELECTION.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF COVINGTON, KENTON COUNTY, KENTUCKY:

Section 1

That Commissioners' Ordinance No. O-49-05 that required a candidate for Covington City Commission to be a resident in the Ward he or she seeks to represent not less than one year prior to his or her election in the City of Covington, Kentucky, is hereby repealed in its entirety effective for the 2008 General Election.

Section 2

That this ordinance shall take effect and be in full force when passed, published and recorded according to law.
