#### ORDINANCE NO. 1984-17

AN ORDINANCE DECLARING A CERTAIN PART OF UNINCORPORATED AREA OF KENTON COUNTY, KENTUCKY TO BE ANNEXED TO THE CITY OF CRESCENT SPRINGS, KENTUCKY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF CRESCENT SPRINGS, KENTUCKY AS FOLLOWS:

## SECTION I

The City Council of the City of Crescent Springs, Kentucky enacted Ordinance No. 1984-12, an Ordinance proposing and intending to annex a part of unincorporated area of Kenton County, Kentucky to the corporate limits of the City of Crescent Springs, Kentucky.

# SECTION II

That pursuant to the provisions of Kentucky Revised Statutes 81a.420 no petitions, notices or objections have been received by the Mayor of said City pursuant to the requirements of the above statute.

# SECTION III

That in light of the declaration as indicated in section number two above, the City Council of the City of Crescent Springs, Kentucky does, by this Ordinance, hereby declare that portion of unincorporated Kenton County, Kentucky hereafter specifally described which was proposed to be annexed in Ordinance No. 1984-12 be and it is hereby declared annexed to the corporate boundaries of the City of Crescent Springs, Kentucky. That said boundaries of the portion of unincorporated Kenton County, Kentucky that is hereby declared to be annexed to the corporate boundaries of the City of Crescent Springs, Kentucky is as follows:

- A certain tract of land situated along the Northwesterly side of Pleasant Run Road approximately one mile in an Easterly direction from Buttermilk Pike in the City of Crescent Springs, County of Kenton, Commonwealth of Kentucky and being the lands of James A. Finke and Ida M. Finke, his wife (Deed Book 560, Page 490), Matthias Toebben (Deed Book 866, Pages 115 through 121), and Bernadine Colligan (Deed Book 235, Page 373) and being more particularly described as follows:
- BEGINNING at a point in the center of said Pleasant Run 'Rbad being 193.68 feet from the Northwesterly corner of Lot Number 8 of the Henry Kraut Estate Subdivision as shown on Copied and Restored Plat Number 355 of the Kenton County Clerk's Office at Covington, Kentucky on a bearing of South 40°-36' East;
- THENCE continuing with the centerline of said road (and through said Lot Number 8) North 230-07' East for a distance of 117.80 feet to a point;

- THENCE leaving the centerline of said road and continuing with the line of said Toebben North 390-41' West for a distance of 20.89 feet to a point;
- THENCE continuing with the line of said Toebben North 390-41' West for a distance of 608.13 feet to a point;
- THENCE continuing with the line of said Toebben North 560-14' East for a distance of 467.74 feet with the line of Lot Number 1 of said Subdivision;
- THENCE leaving the line of said Toebben and continuing with the line of said Finke North 540-42' East for a distance of 438.90 feet to a post;
- THENCE continuing with the line of said Finke North 41 -48' West for a distance of 339.90 feet to a point;
- THENCE continuing with the line of said Finke North 760-10' East for a distance of 349.61 feet to a point in the center of Amsterdam Road;

- THENCE continuing with the centerline of said Amsterdam Road North 420-18' West for a distance of 41.22 feet to a spike in the centerline of said Amsterdam Road:
- THENCE continuing with the centerline of said Amsterdam Road North 51018' West for a distance of 91.40 feet to a spike in the center-line of said Amsterdam Road;
- THENCE leaving said centerline and continuing with the line of said Finke South 670-16' West for a distance of 182.28 feet to a point;
- THENCE continuing with the line of said Finke North 210-57' West for a distance of 47.00 feet to a point;
- THENCE continuing with the line of said Finke North 44<sup>0</sup>-13' East for a distance of 137.71 feet to a point in the center of said Amsterdam Road;
- THENCE leaving the line of said Finke and continuing with the centerline of said Amsterdam Road North 51°-18' West for a distance of 133.10 feet to a point in the centerline of said Amsterdam Road:
- THENCE leaving the centerline of said Amsterdam Road and continuing with the line of said Finke South 45°-38' West for a distance of 144.50 feet to a point;
- THENCE continuing with the line of said Finke North 430-46' West for a distance of 49.30 feet to a point;
- THENCE continuing with the line of said Finke North 080-25' West for a distance of 56.20 feet to a point;
- THENCE continuing with the line of said Finke North 430-00' East for a distance of 100.95 feet to a point in the centerline of said Amsterdam Road;
- THENCE leaving the line of said Finke and continuing in a Northwesterly direction with the centerline of said Amsterdam Road approximately 837.30 feet to a corner to Matthias Toebben;
- THENCE leaving the centerline of said Amsterdam Road and continuing with the line of said Finke South 510-28' West for a distance of 1109.98 feet to a point;

- THENCE continuing with the line of said Finke South 470-30' East for a distance of 1119.00 feet to a 48 inch Oak tree in the line of said Toebben;
- THENCE leaving the line of said Finke and continuing with the line of said Toebben South 550-27' West for a distance of 193.58 feet to a point:
- THENCE continuing with the line of said Toebben South 530-23' West for a distance of 137.68 feet to a point in the line of said Colligan;
- THENCE leaving the line of said Toebben and continuing with the line of said Colligan North 480-30' West for a distance of approximately 334 feet on to the corner of the former land of Krauts Estate;
- THENCE continuing with the line of said Colligan South 470-00' West for a distance of 800.25 feet to a point in the line of Country Squire Estates Subdivision;
- THENCE continuing with the line of said Colligan South 480-30' East for a distance of 1361.25 feet to a point:
- THENCE continuing with the line of said Colligan North 470-15' East for a distance of 800.25 feet to a point in the line of said Toebben;
- THENCE leaving the line of said Colligan and continuing with the line of said Toebben South 40°-36' East to the centerline of said Pheasant Run Road being the said Point of Beginning;
- The above described tract of land contains approximately sixty-nine and one quarter acres.

# SECTION IV

That the City Council hereby and herewith declares that it is desirable for said City to annex that portion as described above to the corporate boundaries of the City of Crescent Springs, Kentucky. This Ordinance is passed pursuant to the applicable provisions of the Kentucky Revised Statutes and particularly 81a.420 et. seq.

# SECTION V

The validity of any section of this Ordinance shall not effect the validity of any other section. All Ordinances or parts of Ordinances in conflict herewith, be and they are hereby repealed. This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
