COMMONWEALTH OF KENTUCKY CITY OF CRESTWOOD ORDINANCE NO. 10, SERIES 1997

SUBJECT: AN ORDINANCE ANNEXING CONTIGUOUS PROPERTY TO THE CITY OF CRESTWOOD, KENTUCKY, BEING A CERTAIN TRACT OF LAND LOCATED IN OLDHAM COUNTY, KENTUCKY, MORE PARTICULARLY HEREINAFTER DESCRIBED.

BE IT ORDAINED BY THE BOARD OF CITY COMMISSIONERS OF THE CITY OF CRESTWOOD, KENTUCKY, THAT:

SECTION ONE: The following territory lying contiguous to the present boundaries of the City of Crestwood, Oldham County, Kentucky shall be annexed into the City of Crestwood, Kentucky in accordance with KRS 81A.410 to 81A.470 and other applicable laws, rules and regulations. Said tract of land is now within the county of Oldham and is adjacent to and contiguous to the present City boundaries and is not located in any other incorporated area and is described as follows:

BEGINNING at an angle point in the southeast line of Briargate Subdivision at a corner with the corporate limits of the City of Crestwood and being the northeast corner of Joan C. Sutcliffe; thence with said line of Briargate Subdivision and the northwest line of said Sutcliffe, South 68 degrees 30 minutes 00 seconds West 586.92 feet to the easterly right-of-way line of Clore Lane; thence with said right-of-way line, North 16 degrees 20 minutes 37 seconds West 527.92 feet; and North 00 degrees 04 minutes 34 seconds West 191.05 feet to a point in the southeast line of Briar Hill Farms, Section 1; thence with said line of Briar Hill Farms, North 45 degrees 00 minutes 00 seconds East 1,170.22 feet to a corner with the lands of Robert F. Lenz; thence with the southwest line of said Lenz, South 44 degrees 50 minutes 04 seconds East 1,069.84 feet to the southeast corner of Briargate Subdivision and being in a northwest line of the City of Crestwood; thence with said line of the City of Crestwood, South 41 degrees 32 minutes 48 seconds West 387.52 feet; and South $6\overline{7}$ degrees 28 minutes 10 seconds West 681.92 feet to the beginning, containing 30.070 acres.

SECTION TWO: The Board of Commissioners hereby finds that the annexation criteria set forth in KRS 81A.410 (1) exist and that no part of the territory to be annexed is presently within the boundaries of an incorporated city.

SECTION THREE: The City Commissioners of the City of Crestwood, Kentucky, further find that all property owners of record within the territory proposed to be annexed have consented to the annexation and no objections or remonstrants have been filed in the manner prescribed by the Kentucky Revised Statutes within sixty (60) days from the date of the enactment of the Ordinance proposing to annex the hereinabove described territory.

SECTION FOUR: Immediately upon the effective date hereof, the Clerk of the City of Crestwood is hereby authorized and directed to publish this Ordinance in the Oldham Era in the absence of a daily or weekly newspaper published within the boundaries of the City of Crestwood.

SECTION FIVE: This Ordinance shall take effect immediately upon its passage, approval and publication.
