**ORDINANCE NO. 3, SERIES 2008**

**SUBJECT:** AN ORDINANCE AMENDING ORDINANCE NO. 1, SERIES 2004, ANNEXING PROPERTY CONTIGUOUS TO THE CITY OF CRESTWOOD, KENTUCKY, BEING A CERTAIN TRACT OF LAND LOCATED IN THE CITY OF CRESTWOOD, OLDHAM COUNTY, KENTUCKY, MORE PARTICULARLY DESCRIBED HEREIN.

BE IT ORDAINED BY THE CITY COMMISSIONERS OF THE CITY OF CRESTWOOD, KENTUCKY, THAT:

SECTION ONE: WHEREAS, Ordinance No. 1, Series 2004, contained a typographical error and it is the intention of the City Commissioners of the City of Crestwood, Oldham County, Kentucky to correct the typographical error as contained in Ordinance No. 1, Series 2004; and,

WHEREAS, the following territory lies contiguous to the present boundaries of the City of Crestwood, Kentucky, and was previously annexed by the City of Crestwood under its Ordinance No. 1, Series 2004, and in accordance with KRS 81A.410 to 81A.470 and other applicable laws, rules and regulations. Said tract of land was previously annexed into the boundaries of Crestwood, Kentucky, and is adjacent and contiguous to the present City boundaries and is not located in any other incorporated area and is described as follows:

18.57 ACRES  
VANDENBARK, COUSINS REAL ESTATE AND  
MURRAY 2000 TRUST

BEGINNING at a point in the westerly right of way of Kentucky Highway 146 at a northeast corner with the City of Crestwood in Oldham County, Kentucky; thence leaving the highway and following the corporate limits, South 65 degrees 34 minutes 15 seconds West 643.45 feet to a point; North 24 degrees 38 minutes 18 seconds West 1,283.15 feet to a point; and North 69 degrees 51 minutes 09 seconds East 643.52 feet to the right of way of Kentucky Highway 146; thence with said right of way, South 24 degrees 43 minutes 36 seconds East 1,235.11 feet to the beginning, containing 18.57 acres per plat dated April 12, 2004, by C. Robert Vinsand, Professional Land Surveyor.

SECTION TWO: The Board of Commissioners hereby finds that the annexation which previously took place under Ordinance No. 1, Series 2004 has met the criteria set forth in KRS 81A.410 (1) and the territory which was previously annexed is not presently

forth in KRS 81A.410 (1) and the territory which was previously annexed is not presently within the boundaries of any other incorporated city.

**SECTION THREE:** The City Commissioners of the City of Crestwood, Kentucky, further find that all property owners of record within the territory which was previously annexed by the City of Crestwood under Ordinance No. 1, Series 2004, have either consented to the annexation or filed no objections or remonstrance in the manner prescribed by the Kentucky Revised Statutes within sixty (60) days from the date of the enactment of Ordinance No. 1, Series 2004, nor have there been any objections to the annexation from the date of the enactment of Ordinance No. 1, Series 2004.


**SECTION FOUR:** Immediately upon the effective date hereof, the Clerk of the City of Crestwood is hereby authorized and directed to publish this Ordinance in The Oldham Era in the absence of a daily or weekly newspaper published within the boundaries of the City of Crestwood.

**SECTION FIVE:** This Ordinance shall take effect immediately upon its passage, approval and publication.
