ORDINANCE NO. 1366-2003

JOHN Y. BROWN III SECRETARY OF STATE COMMONWEALTH OF KENTUCKY

AN ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF CYNTHIANA AND ESTABLISHING APPROPRIATE CLASSIFICATIONS FOR NEWLY ANNEXED APPROXIMATELY PROPERTY CONSISITING OF 13.998 **LYING OF** THE CITY GENERALLY **EAST** ACRES THE COUNTRY **CLUB ESTATES ADJACENT** TO BEING ON THE EAST SIDE OF SUBDIVISION AND CHELSEA DRIVE.

WHEREAS, the City of Cynthiana enacted Ordinance No. 1359 on March 11, 2003 declaring the intent of the City of Cynthiana to annex certain real estate consisting of approximately 13.998 acres more or less generally lying east of Cynthiana adjacent to the Country Club Estates Subdivision and being on the east side of Chelsea Drive, and

WHEREAS, pursuant to KRS 100.209, the City proposed to establish zoning classifications for the newly annexed property and to amend its zoning map accordingly and did further refer the matter to the Cynthiana-Harrison County-Berry Joint Planning Commission for a public hearing and findings as required by law, and

WHEREAS, the Cynthiana-Harrison County-Berry Joint Planning Commission conducted public hearings on April 21 and May 20, 2003 and has subsequently made written findings of fact and conclusions regarding the appropriate zoning classifications for the subject property, and

WHEREAS, the City of Cynthiana desires to adopt the findings of the Cynthiana-Harrison County-Berry Joint Planning Commission and establish zoning by amending its official zoning map as permitted by KRS 100.213 and KRS 100.209,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF CYNTHIANA, KENTUCKY AS FOLLOWS:

SECTION 1: The City Commission hereby adopts the Findings of Fact and Conclusions of Law of the Cynthiana-Harrison County-Berry Joint Planning Commission as the same relate to the zoning classification to be assigned to the newly annexed property which is hereinafter described.

SECTION 2: Pursuant to the recommendation of the Cynthiana-Harrison County-Berry Joint Planning Commission, the zoning classifications of the newly annexed property shall be and hereby is changed to R1, single family residential immediately upon annexation into the city limits.

SECTION 3: The official zoning map of the City of Cynthiana shall be amended to reflect the change as set forth above.

SECTION 5: A map setting forth the zoning classification as established herein is attached hereto as a part hereof pursuant to the requirements of KRS 100.209.

SECTION 6: This Ordinance shall be effective upon approval, passage and publication as required by law.
