AN ORDINANCE ANNEXING CERTAIN TERRITORY, ADJACENT TO AND LYING ON THE EAST SIDE OF THE CITY OF CYNTHIANA, KENTUCKY, AND MAKING IT A PART THEREOF AND WITHIN THE CITY LIMITS OF THE CITY OF CYNTHIANA, KENTUCKY, PURSUANT TO A JUDGMENT OF THE HARRISON CIRCUIT COURT, DATED NOVEMBER 7, 1958.

WHEREAS, an Ordinance was passed by the Board of Commissioners of the City of Cynthiana on the 12th day of August, 1958 proposing to annex certain territory, adjacent to and lying on the east side of the City of Cynthiana, Kentucky, to the City of Cynthiana, Kentucky, and,

WHEREAS, a description of the territory to be annexed was contained in said Ordinance, and.

AN ORDINANCE PROPOSING AND PROVIDING FOR THE ANNEXATION OF CERTAIN TERRITORY ADJACENT TO, AND LYING ON THE EAST SIDE OF THE CITY OF CYNTHIANA, KENTUCKY, AND FOR MAKING IT A PART THEREOF AND WITHIN THE CITY LIMITS OF THE CITY OF CYNTHIANA, KENTUCKY.

Whereas, the City of Cynthiana is desirous of annexing certain territory within the City of Cynthiana, and,

Whereas, all of the Property owners of said territory have petitioned the Board of Commissioners of the City of Cynthiana, Kentucky requesting that said territory be annexed by said City, and,

Whereas, it may be necessary to lay, build and construct sewer lines, water lines, streets and alleys in said territory, and

Whereas, the entire cost of the construction of any such sewer lines, water lines, streets and alleys is to be paid exclusively by the owners of such territory at the time the City directs they shall be layed, built and constructed, and,

Whereas, the City will be benefited by the collection of taxes, water and sewer rentals from such territory and property thereon,

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF CYNTHIANA, KENTUCKY:

1. That the property now owned by the Cynthiana Country Club, Incorporated and Nelson MCLoney, lying and being on the East Side of the City of Cynthiana and adjacent thereto, and in Harrison County, Kentucky and more particularly described as follows be annexed to, and become a part of and within the City

Limits of the City of Cynthiana, Kentucky, to-wit:

Beginning at a point in the Grandview Addition, corner with Sonley Heights Addition; thence S. 46 dag. 30' E. 701.58 feet to a point; thence S. 22 dag. 30' W. 278.58 feet to a point in line of McLoney; thence N. 59 dag. 45' W. 301 feet to a point in line of McLoney and Sonley Heights Addition; thence S. 41 dag. 15' W. 280 feet to a point in line of McLoney and Skidmore; thence S. 73 dag. 25' E. 392 feet to a point in line of McLoney and Cynthiana Country Club; thence S. 22 dag. 30' W. 614.6 feet to the right of way of the Millersburg road; thence with said right of way S. 51 dag. E. 417.12 feet to a point; thence W. 22 dag. 30' E. 1067.88 feet to a point; thence N. 46 dag. 30' W. 1097.58 feet to the line of Grandview Addition; thence S. 37 dag. 30' W. 30 feet, more or less, to the point of beginning.

- 2. A copy of the map, survey or plat, showing the above described boundaries, sewer lines, water lines, streets, and alleys installed therein is to be filed with the City Clerk and with the Clerk of the Harrison County Court.
- 3. The object and purpose of annexing said territory and the making and laying of sewers, water lines, streets and alleys therein in the future, all of which is to be at the exclusive cost of the owners of said property at the time the City shall direct that same be layed, built and constructed, is the benefits to be derived by the City in the taxing of said property and the collection of water and sewer rentals.
- 4. The laying and constructing of any and all sewer lines, streets and alleys in said territory is to be at the exclusive cost of the owners thereof and all are to meet with the City specifications. After such sewer lines, water lines, streets and alleys are fully and completely constructed and accepted by

the City they are to become the property of the City and are to be maintained by it.

- 5. That within thirty days after the adoption, publication and advertisement of this Ordinance, the City Attorney shall file a complaint in the Harrison Circuit Court, in the name of the City, for the purpose of obtaining Judgment of said Court ordering and directing that the territory described herein be annexed to the City of Cynthiana, and that said complaint be filed not less than twenty days before the next succeeding Term of said Court.
- 6. That this Ordinance be deemed to be notice to all of the proposed proceedings in the Harrison Circuit Court.
- 7. That this Ordinance pertaining to the annexation of the above described territory be published in a newspaper, by the City Clerk, for a period of three consecutive weeks, and that said newspaper shall be one that is published in the City of Cynthiana.
- 8. This Ordinance shall become effective from and after its passage, approval and publication according to law.
