Upon motion of the Petitioner, no Answer or other opposition having been filed to the Petition within the 30-day period prescribed by Order of this Court;

IT IS HEREBY ADJUDGED that the Petition is granted and that the City may, by enactment of the appropriate ordinance, annex to the City the territory described in the Petition, which is more particularly described as follows:

LOTS 24 & 25, as shown on plat of RUNNING CREEK ESTATES, Section No. 1, of record in Plat and Subdivision Book 31, Page 21, in the Office of the County Clerk of Jefferson County, Kentucky. More particularly bounded and described as follows: BEGINNING in the Northeasterly line of CHERRY POINT DRIVE at the most Westerly corner of Lot 25, as shown on said plat, thence with the Northwesterly line of Lot 25 aforesaid North 21° 57' 34" East 149.97 feet to another corner of said Lot 25, thence with the Northerly line of Lot 25 aforesaid North 76° 47' 33" East 23.02 Feet to the most Northerly corner of Lot 25 aforesaid, thence with the Easterly line of Lots 24 & 25 as shown on the aforesaid plat South 21° 37' 01" East 205.875 feet and South 14° 11' 23" West 59.02 feet to the Southeast-erly corner of Lot 24 as shown on plat aforesaid, thence with the Southerly line of Lot 24 aforesaid North 69° 56' 36" West 118.81 feet to the Easterly line of CHERRY POINT DRIVE, as shown on plat aforesaid, thence with the Easterly line of CHERRY POINT DRIVE and with a curve to the left, said curve having a radius of 50 feet, North 1° 58' 03" West 37.50 feet and North 46° 00" 58" West 37.50 feet as measured along the chords of said curve to the BEGINNING.
