ORDINANCE NO. 6, SERIES 1992

AN ORDINANCE OF THE CITY OF DOUGLASS HILLS, KENTUCKY,  
ANNEXING TO SAID CITY THE UNINCORPORATED TERRITORY LYING  
ADJACENT TO AND CONTIGUOUS WITH THE PRESENT  
CITY BOUNDARIES, BEING A TRACT OF LAND THAT IS  
OWNED BY OUR SAVIOR LUTHERAN CHURCH  
AND MORE ACCURATELY DEFINED BELOW

WHEREAS, the City of Douglass Hills, Kentucky did on the day of December 14, 1992, duly adopt and enact Ordinance No. 4, Series 1992, proposing the annexation of the area hereinafter described, which was published in the Neighborhoods Section of the Courier-Journal of Louisville, Kentucky, as prescribed by law; and

WHEREAS, the territory is currently contiguous or adjacent to the City's boundaries and is suitable for immediate development for urban purposes without unreasonable delay, and no part of the area to be annexed is included within the boundary of another incorporated City;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF DOUGLASS HILLS, KENTUCKY, AS FOLLOWS:

SECTION ONE: The Unincorporated territory more accurately defined below, and lying adjacent to the present boundaries of the City of Douglass Hills is hereby annexed to and made a part of the City of Douglass Hills, Kentucky.

SECTION TWO: The territory hereby annexed is accurately defined and described as follows:

BEING LOT 8, RUNNING CREEK ESTATES, Section 1, plot of which is of record in Plat and Subdivision Book 31, Page 21, in the Office of the Clerk of the County Court of Jefferson County, Kentucky.

TITLE having been acquired by Deed dated September 18, 1976, and recorded in Deed Book 4887, page 333, in the Office of the Clerk of the County Court of Jefferson County, Kentucky, and rerecorded in Deed Book 4891, page 682, aforesaid records.

SECTION THREE: If any section, sentence, clause or portion of this Ordinance is for any reason declared illegal, unconstitutional, or otherwise invalid, such declaration shall not affect the remaining portions hereof.

SECTION FOUR: This Ordinance shall be effective upon its final passage and publication and the City Clerk is hereby authorized and directed to publish this Ordinance in the Neighborhoods Section of the Courier-Journal of Louisville, Kentucky.

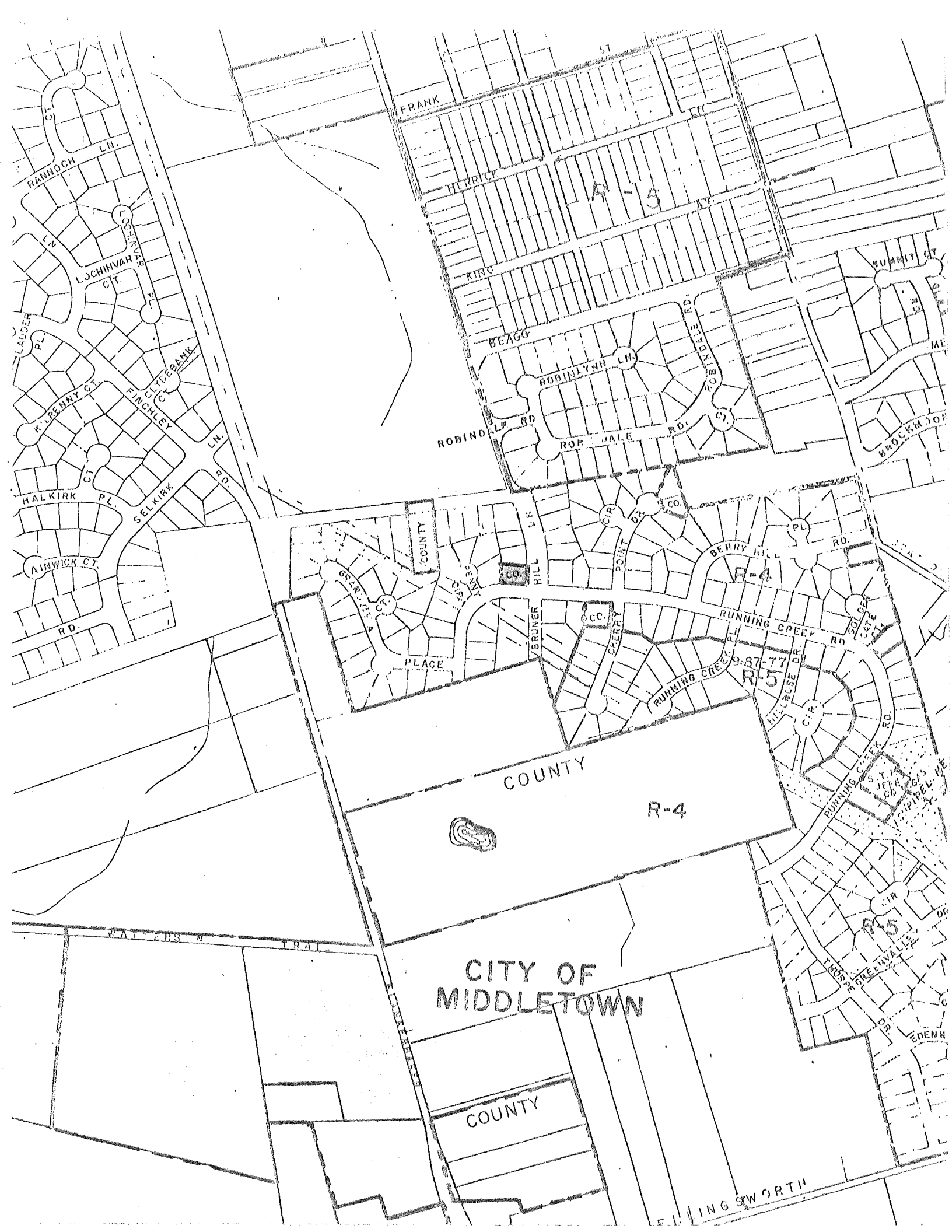
