

**ORDINANCE OF ANNEXATION****Ordinance #04/1/02**

**WHEREAS**, there has been a continual development of property in Eddyville, Lyon County, Kentucky; and

**WHEREAS**, it is desirable and necessary for the consistent well-ordered growth of the City of Eddyville, Kentucky, that the following described property be annexed and brought into the City of Eddyville, to-wit:


- a. Beginning at a point in the existing city limits line where it intersects with the South right-of-way line of P&L Railroad (approximate state plane coordinates N 285,710, E 1,315,155). Thence with the South right-of-way line of P&L Railroad in an easterly direction approximately 2800 feet to the line of Brightwell Farm (N 287,026, E 1,317,674) thence in a southerly direction with the west property line of Brightwell Farm approximately 480 feet to Brightwell southwest corner, thence east with Brightwell property line 650 feet to the original Northwest corner of Dana Beavers property which is the existing city limits as described in 1982 ordinance approximate state plane coordinates (N 286,789, E 1,318,508).
- b. Beginning at a point of intersection of the Existing City Limits in the South right-of-way of the Lyon County Port Authority Road, thence with the South right-of-way line on Port Road in an Easterly direction approximately 3160' to the East right-of-way line of Highway 93, thence in a Northwesterly direction with said rightway line 2230 feet to the existing city limits line.


**WHEREAS**, the owners of the described properties have consented to have said properties annexed into the corporate limits of the City of Eddyville,
