

AN ORDINANCE ANNEXING CERTAIN TERRITORY IN  
PLEASANT ACRES AND CONVENIENT SUBDIVISIONS INTO THE  
CITY OF ELIZABETHTOWN

BE IT ORDAINED by the City of Elizabethtown, that from and after the passage, approval and publication of this Ordinance, that the City of Elizabethtown hereby has and does annex the unincorporated territory, more particularly described below, into the City of Elizabethtown. Said territory is adjacent to the City's existing boundary and because of reasons of population, density, residential, commercial, industrial and governmental use of said land, said property is urban in character and suitable for development for urban purposes without unreasonable delay.

Legal Description - Annexation of Pleasant Acres

BEGINNING at a point in the N right-of-way of Pear Orchard Road, said point being approximately 901.20' NW of the intersection of Jackie Street and Pear Orchard Road; thence N 13° 11' E 649.95'; thence S 75° 54' E 410.20'; thence S 75° 54' E 100'; thence S 77° 17' E 187.87'; thence S 77° 24' E 657.62'; thence S 37° 38' W 331.14' to a point; thence S 37° 38' W 35.38'; thence S 54° 35' W 68.96'; thence S 44° 30' W 54.42'; thence S 38° 50' W 100.99'; thence S 44° 59' W 45.85'; thence S 55° 53' W 7.77' to the N right-of-way of Pear Orchard Road; thence following said right-of-way in a northwesterly direction for approximately 968.05' to the point of beginning.

Legal Description - Annexation of Convenient Subdivision

BEGINNING at an iron pin in the N right-of-way of Pear Orchard Road, said point being the SE corner of Lot 31 of Pleasant Acres; thence N 37° 21' E 1775.4' to an iron pin; thence S 62° 6' E 422.43' to an iron pin; thence S 10° 21' E 632.4' to an iron pin; thence S 10° 32' E 435.4' to an iron pin in the N right-of-way of Pear Orchard Road; thence with said right-of-way in a westerly direction approximately 1686.99' to the point of beginning.


