

AN ORDINANCE ANNEXING CERTAIN TERRITORY INTO THE CITY OF ELIZABETHTOWN

BE IT ORDAINED BY THE CITY OF ELIZABETHTOWN that the property described below be and the same is annexed into the City of Elizabethtown. It is specifically found that it is desirable to annex the following described property, and the same is adjacent to the city's existing boundaries by reason of population, density, commercial, industrial and governmental use of said land. Said property is urban in character and is suitable for development for urban purposes without unreasonable delay.

TRACT I: BEGINNING at a point in the existing corporate boundary, said point being the intersection of the existing corporate boundary with the West side of a county road, also a property line to Ponderosa Manor; thence in a northeasterly direction with the existing corporate boundary along Shaw Creek for approximately 1100' to a point with W.C. Routt; thence in a Southwesterly direction with W.C. Routt and W.T. Buford for approximately 1020' to West side of aforesaid county road; thence in a southeasterly direction with county road for approximately 800' to the point of beginning. This tract contains that portion of P.V.A number S12-3-1 not presently in the corporate boundaries, said portion being approximately 9 acres.

TRACT II: BEGINNING at a point in the existing corporate boundary, said point being the intersection of the existing corporate boundary with the West side of county road, also a property line to Ponderosa Manor; thence in a Southwesterly direction with the existing corporate boundary along Shaw Creek for approximately 1000' to a point with John Greenwell; thence in a Northwesterly direction with John Greenwell for approximately 955' to a point with W.T. Buford; thence in a Northeasterly direction with W.T. Buford for approximately 740' to aforesaid county road; thence in a Southeasterly direction with county road for approximately 800' to the point of beginning. This tract contains that portion of P.V.A. number S12-3-10 not presently in the corporate boundaries, said portion being approximately 16 acres.
