AN ORDINANCE ANNEXING CERTAIN PROPERTY LOCATED
ON JACKIE STREET INTO THE CITY OF ELIZABETHTOWN

BE IT ORDAINED by the City of Elizabethtown that from and after the passage, approval and publication of this Ordinance, the unincorporated territory located on Jackie Street and described in Exhibit "A" attached hereto and made a part hereof, be and the same is, annexed to the City of Elizabethtown, and subject to all Ordinances, Laws, rules, regulations, rights and privileges pertaining thereto. It is specifically found that the said real estate is adjacent to the City's existing boundary, and is urban in character and suitable for development for urban purposes without unreasonable delay, and because of population, density, commercial, industrial and governmental use of said land, the same is suitable for urban purposes.

This Ordinance is enacted pursuant to KRS 81A.420.

EXHIBIT "A"

BEGINNING at the north end of Jackie Street in the West right-of-way line and at the South end of an existing 50 foot wide right-of-way; thence N 77° 24' W 200 feet, with the property of Arnold and McEva Mayse, to a point; thence N 16° 59' E 200 feet, with the property of Mayse to a point, said point being a corner to Mayse and Harned; thence N 16° 59' E 170 feet, with the property line of Jerry and Elizabeth Harned and Mayse, to a point, said point being a corner to Mayse and Harned; thence S 77° 24' E 239.9 feet with the property line of Mayse and Harned to a point, said point being in the west right-of-way line of said existing 50-foot wide right-of-way; thence S 30° 23' W 171.4 feet and S 16° 59' W 6.25 feet, with Harned and with the west right-of-way line of said existing 50-foot wide right-of-way, to a point, said point being a corner to Harned and Mayse; thence S 77° 24' E 50 feet to a point in the east right-of-way line of said 50-foot wide right-of-way, said point being a corner to Fulkerson; thence S 77° 24' 26" E 382.05 feet, with the property line of Robert and Janice Fulkerson, to a corner; thence S 35° 33' 14" W 216.92 feet with Fulkerson's line to a point, corner to Fulkerson and Pleasant Acres Subdivision Lot 28; thence N 77° 24' W 308.42 feet, with Fulkerson's line and with Pleasant Acres, to a point in the east right-of-way line of Jackie Street, said point being at the north end of Jackie Street; thence N 77° 24' W 50 feet to a point in the west right-of-way line of Jackie Street, said point being the point of beginning.
