AN ORDINANCE ANNEXING CERTAIN PROPERTY
KNOWN AS 75 BOTTO AVENUE OWNED BY STEVE JOHNSON

THAT WHEREAS, the City of Elizabethtown has duly enacted and published an Ordinance complying with the provisions of KRS 81A.420 and KRS 424.140 (Subsection 4) and no Petition having been receiving by the Mayor of the City of Elizabethtown, as set out in paragraph 3 of KRS 81.A420.

BE IT THEREFORE ORDAINED by the City of Elizabethtown, Kentucky, that the following described unincorporated territory be and the same is annexed into the City of Elizabethtown, and is a part of the City of Elizabethtown for all purposes and subject to all laws, rules, regulations and ordinances of said Elizabethtown, Kentucky.

Said territory is more particularly described as follows:

BEGINNING at a point in the existing corporate limit of the City of Elizabethtown, said point being a common corner of Richard Southerland and Steve Johnson; thence N 47° 03' E 405.1 feet to a point common to Lee Botto; thence S 41° 44' E 77.3 feet to a point; thence N 46° 15' E 131.9 feet to a point; thence S 41° 15' E 315.8 feet along the West right of way of Helen Lane and Botto Avenue to a point, common to Marion Tharpe; thence S 56° 09' W 522.9 feet to a point, common with Martha Drake; thence N 44° 44' W 308.6 feet to the point of beginning and containing 4.00 acres.

The parcel involved in this area is more specifically known as parcel number 231-40-00-032 in the Office of the Hardin County Property Valuation Administrator.

BE IT FURTHER ORDAINED that the above described real estate be and the same is zoned Residential-1 (R-1).



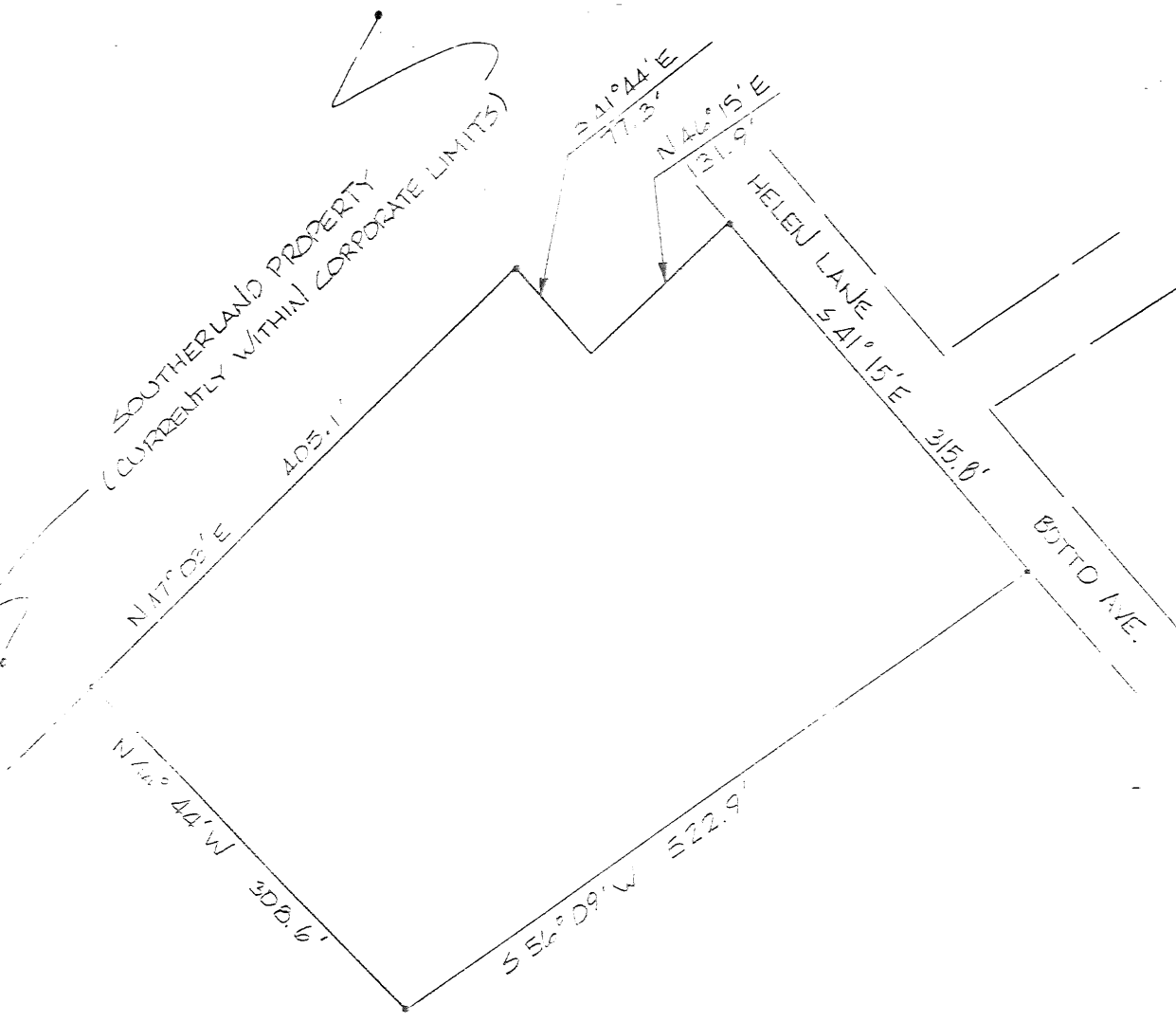
