AN ORDINANCE ANNEXING CERTAIN PROPERTY KNOWN AS NORTH MILES STREET (KY HWY 251) RING ROAD (KY HWY 3005) OWNED BY CLYDE M. HUNT

THAT WHEREAS, the City of Elizabethtown has duly enacted and published an Ordinance complying with the provisions of KRS 81A.420 and KRS 424.140 (Subsection 4) and no Petition having been received by the Mayor of the City of Elizabethtown, as set out in paragraph 3 of KRS 81.A420.

BE IT THEREFORE ORDAINED by the City of Elizabethtown, Kentucky, that the following described unincorporated territory be and the same is annexed into the City of Elizabethtown, and is a part of the City of Elizabethtown for all purposes and subject to all laws, rules, regulations and ordinances of said Elizabethtown, Kentucky.

Said territory is more particularly described as follows:

BEGINNING at a point, said point being the Southeast corner of Hunt property and common with the West right-of-way of KY HWY 251, said point further described as being at the existing corporate limit of the City of Elizabethtown; thence with the corporate limit and the South property line of Hunt S 87° 28′ 06″ W 868.96 feet to a common point with the City of Elizabethtown property; thence with the corporate limit and the West property line of Hunt N 2° 31′ 54″ W 316 feet to a point being the Northwest corner of the Hunt property; thence N 88° 00′ 00″ E approximately 970 feet to a point, said point being common corner with the Hunt and Nelson properties and being in the West right-of-way of KY HWY 251; thence in a Southerly direction with the West right-of-way of KY HWY 251 approximately 340 feet to the point of beginning.

The parcel involved in this area is more specifically identified as parcel number 219-30-00-003 in the Office of the Hardin County Property Valuation Administrator.
