AN ORDINANCE AMENDING AN ORDINANCE ANNEXING CERTAIN TERRITORY ALONG
U.S. HIGHWAY 31-W SOUTH INTO THE CITY OF ELIZABETHTOWN

BE IT ORDAINED by the City of Elizabethtown, that from and after the passage, approval and publication of this Ordinance, that the City of Elizabethtown hereby has and does annex the unincorporated territory, more particularly described below, into the City of Elizabethtown. Said territory is adjacent to the City's existing boundary, and because of reasons of population, density, residential, commercial, industrial and governmental use of said land. Said property is urban in character, and suitable for development for urban purposes without unreasonable delay:

U.S. 31-W South

Beginning at a point being the intersection of the Eastern right-of-way line of U.S. 31-W and the existing corporate boundaries; thence following said right-of-way in a southerly direction approximately 2300' to a point, said point being the SW property corner of the Ray Mackey and Clarence Burman property, thence with the Mackey and Burman property in an Easterly direction approximately 490'; thence in a Southerly direction approximately 200'; thence in an Easterly direction approximately 1250'; thence in a Northerly direction approximately 810' to a point being the NE property corner of Mid-America Warehousing, Inc.; thence with said boundary in a NW direction approximately 1480' to a point being the SE property corner of Kato Express, Inc., then following that said boundary in a Northerly direction approximately 1480' to a point being the said boundary in a Northerly direction approximately 1480' to a point being the SE corner of the Ray Mackey property; thence following said boundary in a NW direction approximately 200' to the existing corporate limits; thence following said limits in an Easterly direction approximately 480' to the point of beginning. (This tract of land contains, in total, the following P.V.A. lots: S15-1-14 (Mackey & Burman) S15-1-15 (Mid-America Warehousing and Distributing, Inc.), S15-1-35 (Kato Express, Inc.), S15-1-37 (Homer Carter) S15-1-16 (W. H. Carter, S15-1-31 (The Interdenominational Gospel Church), S15-1-17 (Jerome Dawson), S15-1-18 (Robert Cook), S15-1-19 (Emmett Dailey), S15-1-20 (Emmett Dailey), and S15-1-21 (Ray Mackey).


