A MUNICIPAL ORDER OF THE CITY OF ERLANGER, IN KENTON COUNTY KENTUCKY DECLARING A VACANCY IN THE MEMBERSHIP OF THE ERLANGER CITY COUNCIL AND APPOINTING Suzan Mann AS A MEMBER OF THE ERLANGER CITY COUNCIL FOR THE UNEXPIRED TERM OF KATHY CAHILL.

WHEREAS, Kathy Cahill was duly elected as a member of the City Council of the City of Erlanger at the general election thereof on November 3, 2020; and

WHEREAS, Kathy Cahill became deceased on July 15, 2021; and, as a consequence thereof, there now exists a vacancy in the membership of the Erlanger City Council.

NOW, THEREFORE, it is hereby Resolved and Ordered by the City Council of the City of Erlanger as follows:

SECTION 1.0 – Recognition of Vacancy

Kathy Cahill became deceased on July 15, 2021.

SECTION 2.0 – Declaration of Vacancy

A vacancy now exists in the membership of the Erlanger City Council due to the passing of Kathy Cahill.

SECTION 3.0 – Appointment of Steven Dean

Steven Dean of 452 Commonwealth Avenue is hereby (Name) (Address) Erlanger, KY 41016 appointed as a member of the City Council of the City of Erlanger for the unexpired term of Kathy Cahill.

SECTION 4.0 – Provisions Severable



OATH OF OFFICE AFFIDAVIT

Before me, Mayor Jessica Fette, personally appeared Steven Dean, appointed City Council Member in the City of Erlanger, Kentucky to take the oath of office as required under Section 228 of the Kentucky Constitution.
