ORDINANCE NO. 57 SECRETARY OF STATE
COMMONWEALTH OF KY.
AN ORDINANCE ANNEXING A BOUNDARY OF LAND
TO THE CITY OF EUBANK, KENTUCKY

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF EUBANK,
KENTUCKY:

That the City of Eubank, Kentucky, does hereby annex and make a part of the City of Eubank, Kentucky, a boundary of unincorporated territory which is adjacent to property now contained in the City Limits and which territory is bounded and described as follows:

Beginning at a highway right of way marker in the West right of way line of U. S. Hwy. 27, approximately 800 feet from the junction of U. S. 27 and Ky. 70; thence running S 83° 50' W 2940 feet to a steel pin; thence S 81° 10' W 1802.5 feet to a steel pin in the East right of way line of the Southern Railway right of way and in the South right of way line of Ky. 70; thence with said right of way line three calls: S 89° 30' W 538 feet; N 77° 00' W 260 feet; N 66° 50' W 338 feet to a steel pin; thence leaving Highway 70 and running N 9° 00' E 3410 feet to the Southeast corner of a spring box; thence with old city limits the following eight calls: thence S 180 poles to a point; thence E 66 poles; thence S 72° E 62 poles; thence N 25° E 53 poles; thence N 110 poles; thence N 25° W 65 poles; thence N 75 poles to a point in the East right of way line of Ky. 1247; thence crossing Ky. 1247 W 45 poles to a steel pin in the Southern Railway fence; thence with Southern Railway fence N 1° 40' E 552 feet; thence still with said fence N 3° 50' W 221 feet to a steel post in said fence; thence crossing Southern Railway S 83° 5' E 973 feet to a post in the West right of way line of Ky. 1247; thence crossing Ky. 1247 S 36° 20' E 63.0 feet to a post; thence S 82° 00' E 957 feet to a 10" black oak; thence S 19° 00' E 367 feet to a point in the center line of county road; thence S 33° 00' E 480 feet to a point; thence S 35° 45' E 442 feet to a point; thence S 36° 10' E 640 feet to a point in the West right of way line of U. S. Hwy. 27; thence with said right of way S 11° 00' E 1466 feet to a pin on shoulder of U. S. Hwy. 27; thence leaving said right of way N 89° 00' W 133 feet to a stone property line marker; thence S 15° 15' E 2133 feet to the point of beginning, as surveyed by J. H. Sturgill, L. S. No. 470.

All ordinances or parts of ordinances in conflict herewith
are hereby repealed.
