JUDGMENT

JOHN B. ABBOTT ETC.

ON

PETITION EX PARTE NO. 4847

This cause came on to be heard on the petition and evidence, and upon due consideration the Court finds that the petition herein is signed by more than two-thirds of the persons entitled to vote living within the boundary of the proposed town of Ferguson, and that due legal notice of the filing of said petition used the object thereof has been given and proper publication made thereof in two weekly issues of the Somerset Journal, a newspaper of general circulation published in the city of Somerset and County of Pulaski, and the Court being satisfied that the population within the territory of the prescribed boundary of the proposed town of Ferguson, is sufficient and no defense being interposed and all of the allegations of the petition being true, the prayer of the petition is granted.

WHEREFORE, it is decreed and adjudged by the Court, that the said proposed town of Ferguson, be and the same is hereby established in and including the territory of the following boundary to wit:

Beginning at the N.W. corner of the house where George Bruce now lives: thence S. 19 E. 160 poles to a stone in Benjamin Cundiff's field: thence N. 71 E. 160 poles to a stone in Lewis Cover's field, including John A. Wood: thence N. 19 W. 160 poles to a stone, including Martin Brandon and S.W. Newton: thence S.71 W. passing through the south ~~saddles~~ ^{gullies} pond at 84 poles and crossing

It is further ordered and adjudged by the Court that C.E. White, James Taylor, H.J. Sutton, Martin Brandon and E.W. Tarter be and they and each of them are hereby appointed Trustees for the said town of Ferguson.

It is ordered and John B. Abbott be and he is hereby appointed Police Judge of the said town of Ferguson and that his appointment be certified to the Judge of the Pulaski County Court by the Clerk of the Pulaski Circuit Court.

It is ordered and adjudged that Leo Hatfield be and he is hereby appointed Marshal of the said town of Ferguson.

It is ordered and adjudged that Newell Clark be and he is hereby appointed assessor of the said town of Ferguson.

It is further ordered and adjudged by the Court that all of the officers herein appointed for said town of Ferguson shall hold their respective office until the next election at which officers for cities and town maybe elected, and until their successors are elected and qualified; all the officers herein before appointed for the said town of Ferguson, shall before entering upon the duties of the office qualify as required by law.

It is further ordered that the petitioners herein cause a copy of these orders and judgment to be published in the Somerset Journal, a newspaper of general circulation published in the city of Somerset Pulaski County, Kentucky.

It is further ordered and adjudged that the petitioners herein pay the Cost of this proceeding, for which Judgment is rendered against them.
