ORDINANCE NO. 26

AN ORDINANCE DEFINING THE BOUNDARY OF
A TERRITORY PROPOSED TO BE ANNEXED
TO THE CITY OF FERGUSON, KENTUCKY


BE IT ORDAINED by the Board of Trustees of the City of Ferguson, Kentucky, that it does hereby annex and make a part of the City of Ferguson, Kentucky, the territory which is bounded and described as follows:

BEGINNING at a point in the centerline of Jacksboro Street, said point the northern boundary line of Ferguson City Limits and also being 1032.4' from the northwest corner of said City Limits; thence N 8° 35' 24" W a distance of 307.0' with Jacksboro Street to a point; thence N 29° 42' 05" E a distance of 2114.1' to a point; thence N 51° 58' 11" E a distance of 2417.5' to a point; thence S 86° 24' 34" E a distance of 681.66' to a point; thence S 16° 57' 36" E a distance of 2012/37' to a point; thence N 71° 41' 51" E a distance of 684.8' to a point in the west boundary line of Hillendale Subdivision; thence with Hillendale line S 19° 57' 58" E a distance of 818.82' to a point; thence with said line N 30° 01' 55" E a distance of 72.49' to a point; thence with said Hillendale line S 60° 10' 02" E a distance of 427.44' to a point; thence with said line N 86° 09' 08" E a distance of 300.62' to a point in Hillendale Subdivision line; thence leaving said line S 2° 35' 24" W a distance of 840.2' to a point; thence S 64° 05' 37" W a distance of 1120.7' to a point; thence S 9° 24' 23" E a distance of 488.8' to a point on Gover Lane; thence with Gover Lane S 79° 50' W a distance of 2398.2' to a point on the south side of Gover Lane; thence with said lane S 66° 00' W a distance of 205.0'; thence S 60° 45' W a distance of 443.0'; thence leaving Gover Lane S 14° 50' E 330.0' to a corner; thence S 34° 00' E 120.0' to a corner; thence S 13° 10' E 620.0' to a corner, common to Laurel Warehousing Corporation and the Haney Farm; thence S 83° 18' 30" W 183.7' to a corner; thence N 15° 56' 30" W a distance of 78.0' to a corner; thence S 74° 1' W a distance of 186.3' to a corner; thence S 20° 34" E a distance of 120.5' to a corner; thence S 74° 26' W a distance of 525.0' to a corner; thence N 14° 23' E a distance of 11.9' to a corner; thence S 74° 00' W a distance of 29.6' to a corner; thence S 12° 00' E a distance of 102.0' to a corner; thence S 76° 07' W a distance of 66.0' to a corner common with R/W of Murphy Avenue and Laurel Warehousing; thence with R/W of Murphy Avenue S 16° 2' 30" E a distance of 315.6' to a corner common to Murphy Avenue R/W, Laurel Warehousing, and Burley Belt; thence with Murphy Avenue R/W S 19° 30' E a distance of 52.0' to a point common to Southern Railroad and

Burley Belt Access Road; thence with R/W of Murphy Avenue S 18° 15' E a distance of 499.0' to a point; thence with said R/W S 20° 20' E a distance of 65.0' to a point; thence S 21° 20' E a distance of 62.0' to a point; thence with said R/W S 26° 30' E a distance of 329.0' to a point; being a corner common to the R/W of Murphy Avenue, Southern Railroad, and the Crane Company; thence S 61° 39' W a distance of 468.0' to a corner in Southern Railroad R/W; thence S 61° 39' W 225.0' to Lear Siegler corner in Southern Railroad R/W; thence with Lear Siegler property line N 28° 21' W a distance of 293.3' to a corner; thence S 79° 30' W a distance of 196.0' to a corner; thence S 11° 50' E a distance of 571.4' to a corner; thence S 4° 13' W a distance of 84.0' to a corner in the R/W of access road to Lear Siegler plant; thence N 88° 38' W a distance of 463.0' to the centerline of Kentucky Highway 1247; thence with the centerline of Kentucky 1247 N 20° 12' E a distance of 190.4' to a point; thence N 6° 03' W a distance of 232.0' to a point; thence N 27° 13' W a distance of 359.0' to a point; thence N 10° 37' W a distance of 672.8' to a point; thence N 8° 54' W a distance of 594.8' to a point; thence N 17° 14' E a distance of 273.3' to a point; thence N 35° 34' E a distance of 323.4' to a point; thence N 9° 30' W a distance of 362.1' to a point in the present Ferguson City Limits; thence with the present Ferguson City Limit line N 72° 15' E a distance of 1460.0' to a corner; thence with city limit line N 17° 45' W a distance of 2640.0' to a corner; thence with said line S 72° 15' W a distance of 1607.6' to the point of beginning.


All ordinances or parts of ordinances in conflict herewith are hereby repealed.
