ORDINANCE NO. 34


AN ORDINANCE DEFINING THE BOUNDARY OF A  
TERRITORY PROPOSED TO BE ANNEXED  
TO THE CITY OF FERGUSON, KENTUCKY

BE IT ORDAINED by the Board of Trustees of the City of  
Ferguson, Kentucky, that it does hereby annex and make a part of the City  
Ferguson, the territory which is bounded and described as follows:

Beginning at a point in the center line of Ky. 1247  
near Elihu, Kentucky, in the CNO & TP Railroad line;  
thence with the center line of Ky. 1247 as follows:  
N 59° 06' W - 101.0; N 79° 13' W - 86.0; S 84° 30' W  
102.0'; S 79° 30' W - 391.2'; thence leaving the road  
and with Tecumseh line; N 10° 06' W - 1090.5'; thence  
N 37° 00' W - 63.0"; thence N 16° 00' E - 303' to a  
corner; N 61° 39' E - 1300"; N 28° 21' W - 3250';  
N 27° 30' W - 150' corner to Burley Belt, Haney and  
CNO & TP Railroad; N 81° 32' E - 1635"; N 42° 35' E -  
812'; N 66° 15' W - 428'; N 00° 30' W - 947";  
N 07° 25' W - 805"; N 82° 15' E - 478.5"; S 30° 30' E -  
1546' to the CNO & TP Railroad Line; thence with the  
Railroad line as follows: S 80° 35' E - 326.5';  
S 04° 45' E - 1500"; S 20° 00' W - 764.6"; S 33° 06' E -  
1988.3"; S 51° 52' W - 674.5"; S 57° 57' W - 1038.59";  
S 70° 25' W - 997.1"; S 21° 32' E - 495"; S 62° 30' W -  
1168'; S 11° 31' E - 520.8' to the point of beginning.

All ordinances or parts of ordinances in conflict herewith are  
hereby repealed.
