ORDINANCE NO. 776

AN ORDINANCE ANNEXING A PARCEL OF LAND AT THE SOUTHWESTERN LIMITS OF THE CITY OF GEORGETOWN, KENTUCKY, PURSUANT TO JUDGMENT AND ORDER OF SCOTT CIRCUIT COURT.

Whereas, the territory described herein has been ordered to be annexed to the City of Georgetown by virtue of Judgment and Order of the Scott Circuit Court entered June 14, 1957, in the office of the Scott Circuit Clerk, attested copy of which is attached hereto;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNCIL OF THE CITY OF GEORGETOWN, KENTUCKY, AS FOLLOWS:

Section 1. The following described territory is hereby annexed to and made part of the City of Georgetown, Kentucky:

A parcel of land lying along the western city limits of Georgetown, Scott County, Kentucky, and more particularly described as follows:

Beginning at a pin in the south right-of-way of U. S. Highway 62 & 227, (Commonly known as West Main Street) and the east r/w line of Kentucky Avenue, which point is the existing city limits of Georgetown, Kentucky. Thence down the south right-of-way line of U. S. 62 & 227 N  $06^{\circ} 30'$  west 878.00 feet to a new creosoted post. Said post being in the fence line between the highway right-of-way and the property of Vertna Hawkins Mason. Thence along the line of Mason. Thence along the line of Mason S  $0^{\circ} - 15'$  east 175.80 feet to a new creosoted post, south  $30^{\circ} - 45'$  east 108.00 feet to a new post and south  $32^{\circ} 15'$  east 420.00 feet to a new post located in the property line between Vertna Hawkins Mason and Lewis Watson; thence along the property of Watson, south  $27^{\circ} - 30'$  east 401.80 feet to a new post and south  $30^{\circ} - 10'$  east 607.80 feet to a new post in the property line between Mrs. Artie Risk Moore and Lewis Watson. Said point being the present city limits line north  $2^{\circ} - 14'$  west 717.00 feet; to a point in the north right of way line of Clinton Street and the east right of way of Kentucky Avenue; thence along the east right of way line of Kentucky Avenue north  $0^{\circ} - 20'$  east 1007.10 feet to point of beginning. Said tract of land containing .027 square miles.

The above description being according to new survey of J. R. Miller, Jr., registered civil engineer, dated July 29, 1956.

Section II. If any part, section, clause, phrase or word of this Ordinance is for any reason held to be invalid, such invalidity shall not affect the remaining portions.

Section III. This Ordinance shall be effective upon its passage and publication according to law.

WHEREUPON, upon motion and by unanimous vote of all Councilmen present in quorum duly assembled, this Ordinance was passed and approved this 3rd day of July, 1957.



JUDGMENT AND ORDER ANNEXING TERRITORY

This cause coming on for hearing on the motion of counsel for the petitioner, the City of Georgetown, Kentucky, for judgment, and the Court having rendered Findings of Fact and Conclusions of Law herein, and having directed the entry of a judgment in accordance with such Findings of Fact and Conclusions of Law, and no defense having been made herein and no further time having been granted for same, and the Court being advised, it is hereby ordered and adjudged as follows:

(1) The following described territory is hereby annexed to, and made part of, the corporate limits of the City of Georgetown, Kentucky:

A parcel of land lying along the Western City Limits of Georgetown, Scott County, Kentucky, and more particularly described as follows:

Beginning at a pin in the South Right of Way line of U. S. Highway 62 & 227, (Commonly known as West Main Street) and the East R/W line of Kentucky Avenue, which point is the existing city limits of Georgetown, Ky. Thence down the South Right of Way line of U. S. 62 & 227, N. 86° - 30' West 878.00 feet to a new creosoted post. Said post being in the fence line between the highway right-of-way and the property of Vertna Hawkins Mason. Thence along the line of Mason S. 0° - 15' E, 175.80 feet to a new creosoted post, S. 30° - 45' E. 408.00 feet to a new post and S. 32° - 15' E 420.00 feet to a new post located in the property line between Vertna Hawkins Mason and Lewis Watson. Thence along the property of Watson S. 27° - 30' E. 401.80 feet to a new post and S. 30° - 10' E 607.80 feet to a new post in the property line between Mrs. Artie Risk Moore and Lewis Watson. Said point being the present city limits line N. 2° - 14' W. 717.00 feet to a point in the North right of way line of Clinton

Street and the east right of way line of Kentucky Avenue. Thence along the east right of way line of Kentucky Avenue N.  $0^{\circ} - 20'$  E 1007.10 feet to point of beginning. Said tract of land containing .027 square miles.

The above description being according to new survey of J. R. Miller, Jr., registered civil engineer, dated July 29, 1956.

(2) It is further ordered and adjudged that the Clerk of this Court make and certify to the Board of Council of the City of Georgetown, Kentucky, a copy of this Judgment and Order, to the end, that same may be spread upon the records of said Board of Council.
