## CITY OF GEORGETOWN ORDINANCE NO. 98-006

AN ORDINANCE RELATED TO THE ANNEXATION OF TWO (2) PARCELS OF LAND CONTAINING A TOTAL OF 30.54 ACRES (PARCEL 1 CONSISTING OF 14.47 ACRES AND PARCEL 2 CONSISTING OF 16.07 ACRES), MORE OR LESS, OWNED BY BALL HOMES, INC., A KENTUCKY CORPORATION, SITUATED ADJACENT TO AND WEST OF BRADFORD PARK OFF U.S. 25 AT THE SHOWALTER DRIVE INTERSECTION, ADJACENT TO AND WEST OF THE CITY LIMITS OF THE CITY OF GEORGETOWN, SCOTT COUNTY, KENTUCKY.

WHEREAS, Ball Homes, Inc., a Kentucky corporation, owner of the property described herein, has consented to the annexation of said property; and

WHEREAS, all appropriate steps required under Chapter 81A of the Kentucky Revised Statutes have been performed or waived; and

WHEREAS, a copy of said consent having been made a part of the record in this matter and available for review with the minutes of this meeting; and

WHEREAS, said property is now embraced within the County of Scott, Kentucky, and is contiguous to the existing city limits and, having urban character and suitability for further urban development, is appropriate for annexation in its entirety to the City of Georgetown.

### NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF GEORGETOWN, KENTUCKY:

SECTION I. <u>PURPOSE</u>: The hereinafter described property is urban in character, suitable for further urban land use development without unreasonable delay, and is contiguous to the existing city limits of the City of Georgetown. It is, therefore, desirable to annex this property to the City of Georgetown, extending the boundaries of the city to include this property described as follows:

Being all of Parcels 1 and 2 as shown on the Minor Subdivision Plat of Bradford Place, Georgetown, Scott County, Kentucky, which appears of record in Plat Slide No. 1776, in the Scott County Clerk's Office, Scott County, Kentucky, which plat is attached hereto, made a part hereof and incorporated herein by reference as Exhibit "A".

Being the same property conveyed to Ball Homes, Inc., a Kentucky corporation, by deed from Alice Thomas Ford, a single person, Ford Farm Partners I, a Kentucky limited partnership, and Ford Farm Partners II, Ltd., a Kentucky limited partnership, dated May 5, 1997, and of record in Deed Book 225, Page 64, in the Scott County Clerk's Office, Scott County, Kentucky.

SECTION II. <u>ANNEXATION</u>: The above described property is hereby annexed into the City of Georgetown, all technical requirements having been satisfied or waived by consent being filed with the minutes of Georgetown City Council meeting dated the <u>7</u> day of <u>May</u>, 1998.

SECTION III. <u>ZONE CLASSIFICATION</u>: The annexation of this property shall not affect its zoning classification.

### CONSENT TO ANNEXATION

NOW THEREFORE, the undersigned property owner hereby consents, pursuant to KRS 81A.500, to the annexation by the City of Georgetown, Kentucky, of

FURTHER, the undersigned property owner agrees that the City of Georgetown, Kentucky, may enact an Ordinance annexing the Consent Area to the City of Georgetown, Kentucky.

FURTHER, the undersigned property owner covenants and agrees that it will not sue the City of Georgetown, Kentucky, or any of its officers, agents, employees or representatives or prosecute any action to which the City of Georgetown, Kentucky, or any of its officers, agents, employees or representatives is a party for or on account of the annexation of the Consent Area.

FURTHER, the undersigned property owner hereby waives the requirements of KRS 81A.050 and KRS 81A.060 and any and all other requirements for annexation of the Consent Area.




