CITY OF GEORGETOWN ORDINANCE NO. 06-057

AN ORDINANCE RELATED TO THE ANNEXATION OF CERTAIN REAL PROPERTY CONTAINING 27.171 ACRES, MORE OR LESS, OWNED BY THE NORTHSIDE CHRISTIAN CHURCH, INC., SITUATED ON THE WEST SIDE OF THE U.S. 460 BY-PASS JUST SOUTH OF ITS INTERSECTION WITH U.S. 460 ON THE WEST SIDE OF THE CITY LIMITS OF THE CITY OF GEORGETOWN IN SCOTT COUNTY, KENTUCKY.

WHEREAS, the owner, The Northside Christian Church, Inc., a Kentucky corporation, has consented to the annexation of certain real property consisting of 27.171 acres, more or less, situated on the west side of the U.S. 460 By-Pass just south of its intersection with U.S. 460 on the west side of the city limits of the City of Georgetown in Scott County, Kentucky; and

WHEREAS, all appropriate steps required under Chapter 81A of the Kentucky Revised Statutes have been performed or waived; and

WHEREAS, a copy of said consent having been made a part of the record in this matter and available for review with the minutes of this meeting; and

WHEREAS, said property is now embraced within the County of Scott, Kentucky, and is contiguous to the existing City Limits and, having urban character, is appropriate for annexation in its entirety to the City of Georgetown.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF GEORGETOWN:

SECTION I. <u>PURPOSE</u>: The hereinafter described property is urban in character and is contiguous to the existing City Limits of the City of Georgetown. It is, therefore, desirable to annex this property to the City of Georgetown, extending the boundaries of the City to include this property described as follows:

SEE LEGAL DESCRIPTION OF PROPERTY ANNEXED (27.171 ACRES), ATTACHED HERETO, INCORPORATED HEREIN, AND MADE A PART HEREOF BY REFERENCE AS EXHIBIT "A".

See drawing showing location of the property hereby annexed, attached as EXHIBIT "B".

BEING the same property conveyed to The Northside Christian Church, Inc., a Kentucky corporation, by deed from Evelyn H. Buchanan, a widow, et al, dated May 16, 2002, and of record in Deed Book 265, Page 42, in the Scott County Clerk's Office, Scott County, Kentucky.

SECTION II. <u>ANNEXATION</u>: The above described real property is hereby annexed into the City of Georgetown, all technical requirements having been satisfied or waived by consent being filed with the minutes of the Georgetown City Council meeting dated the <u>Gto</u> day of <u>Optil</u>, 2006.

SECTION III. <u>ZONE CLASSIFICATION</u>: The annexation of this property shall not affect its zoning classification.

SECTION IV. <u>EFFECTIVE DATE</u>: This Ordinance shall become effective upon its publication on the <u>actual</u> day of <u>April 1</u>, 2006.

WHEREUPON, the foregoing Ordinance was read for the first time on the day of March, 2006, read for the second time, passed and approved on the btday of April, 2006.

S 09°36'43" W 996.58 feet to a ½ inch rebar with I.D. cap "TEI 2586" and outside boundary of Walnut Ridge Farm and in line of Harace Gaines; thence with line of Gaines

N 76°52'00" W 1027.55 feet, passing a ½ inch rebar with I.D. cap "TEI 2586" at 980.24 feet, to the center of Cane Run Creek and line of Bobby Clayton; thence with said creek and Clayton

N 40°52'00" W 30.00 feet; thence

N 38°32'00" W 330.00 feet; thence

N 53°37'00" W 220.00 feet at stone dam and corner of Clarence True; thence leaving the creek and with line of True

N 15°00'18" E 101.00 feet, passing a ½ inch rebar with I.D. cap "TEI 2586" at 95.98 feet to corner of stone wall; thence

N 83°07'10" E 518.00 feet to a ½ inch rebar with I.D. cap "TEI 2586"; thence

N 63°09'16" E 961.47 feet to a ½ inch rebar with I.D. cap "TEI 2586" at stone wall; thence along stone wall

N 85°24'12" W 103.00 feet, passing a ½ inch rebar with I.D. cap "TEI 2586" at 0.72 feet to a ½ inch rebar with I.D. cap "TEI 2586" at fence corner; thence

N 04°38'17" E 197.00 feet to a ½ inch rebar with I.D. cap "TEI 2586" at corner of Kentucky Transportation Cabinet tract; thence with south line of said tract
